

# SENATE BILL No. 506

September 24, 1991, Introduced by Senators FAXON,  
POLLACK and STABENOW and referred to the  
Committee on Health Policy.

A bill to amend Act No. 368 of the Public Acts of 1978,  
entitled as amended  
"Public health code,"  
as amended, being sections 333.1101 to 333.25211 of the Michigan  
Compiled Laws, by adding section 21054u.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Section 1. Act No. 368 of the Public Acts of 1978, as  
2 amended, being sections 333.1101 to 333.25211 of the Michigan  
3 Compiled Laws, is amended by adding section 21054u to read as  
4 follows:

5       SEC. 21054U. (1) AS USED IN THIS SECTION, "CHILD HEALTH  
6 SUPERVISION SERVICES" MEANS THE PERIODIC REVIEW OF A CHILD'S  
7 PHYSICAL AND EMOTIONAL STATUS BY A PHYSICIAN OR PURSUANT TO A  
8 PHYSICIAN'S SUPERVISION. A REVIEW SHALL INCLUDE A HISTORY,  
9 COMPLETE PHYSICAL EXAMINATION, DEVELOPMENTAL ASSESSMENT,

1 ANTICIPATORY GUIDANCE, APPROPRIATE IMMUNIZATIONS, AND LABORATORY  
2 TESTS IN KEEPING WITH PREVAILING MEDICAL STANDARDS.

3       (2) EFFECTIVE JANUARY 1, 1993, A HEALTH MAINTENANCE ORGANI-  
4 ZATION GROUP OR INDIVIDUAL CONTRACT THAT PROVIDES COVERAGE FOR A  
5 FAMILY MEMBER OF THE SUBSCRIBER SHALL, AS TO THAT FAMILY MEMBER'S  
6 COVERAGE, ALSO PROVIDE THAT THE COVERAGE APPLICABLE FOR CHILDREN  
7 INCLUDE COVERAGE FOR CHILD HEALTH SUPERVISION SERVICES FROM THE  
8 MOMENT OF BIRTH THROUGH THE AGE OF 21. EACH SUCH CONTRACT SHALL  
9 PROVIDE COVERAGE, AT A MINIMUM, FOR CHILD HEALTH SUPERVISION  
10 SERVICES AT APPROXIMATELY THE FOLLOWING AGE INTERVALS: BIRTH,  
11 2 MONTHS, 4 MONTHS, 6 MONTHS, 9 MONTHS, 12 MONTHS, 15 MONTHS,  
12 18 MONTHS, 2 YEARS, 3 YEARS, 4 YEARS, 5 YEARS, 6 YEARS, 8 YEARS,  
13 10 YEARS, 12 YEARS, 14 YEARS, 16 YEARS, 18 YEARS, AND 20 YEARS.  
14 A CONTRACT MAY PROVIDE THAT CHILD HEALTH SUPERVISION SERVICES  
15 THAT ARE RENDERED DURING A PERIODIC REVIEW SHALL ONLY BE COVERED  
16 TO THE EXTENT THAT THOSE SERVICES ARE PROVIDED BY OR UNDER THE  
17 SUPERVISION OF A SINGLE PHYSICIAN DURING THE COURSE OF 1 VISIT.  
18       (3) COVERAGE FOR CHILD HEALTH SUPERVISION SERVICES SHALL BE  
19 EXEMPT FROM ANY COPAYMENT, COINSURANCE, DEDUCTIBLE, OR DOLLAR  
20 LIMIT PROVISIONS IN THE CONTRACT, AND SUCH EXEMPTION SHALL BE  
21 EXPLICITLY PROVIDED FOR IN THE CONTRACT.
