**14 AREA AGENCIES ON AGING**

**A SUMMARY OF HOUSE BILL 4914 INTRODUCED 7-1-93**

Currently, under the Older Michiganians Act, the Commission on Services to the Aging is required to designate both planning and service areas and an area agency on services to the aging within each of these planning and service areas. House Bill 4914 would amend the act to delete the provision that the commission designate planning and service areas. Under the bill, the following 14 Planning and Service areas would be established, and the commission would designate an area agency on services to the aging within each of the areas created:

AREA	MUNICIPALITIES SERVED
#1	Detroit, Hamtramck, Highland Park, Grosse Pointe, Grosse Pointe Farms, Grosse Pointe Park, Grosse Pointe Shores, Grosse Pointe Woods, and Harper Woods.
#2	All of Wayne County, except for the cities served by Area #1.
#3	Livingston, Macomb, Monroe, Oakland, Washtenaw, and St. Clair counties.
#4	Jackson, Hillsdale, and Lenawee counties.
#5	Barry, Branch, Calhoun, Kalamazoo, and St. Joseph counties.
#6	Berrien, Cass, and Van Buren counties.
#7	Genesee, Lapeer, and Shiawassee counties.
#8	Clinton, Eaton, and Ingham counties.
#9	Bay, Clare, Gladwin, Gratiot, Huron, Isabella, Midland, Saginaw, Sanilac, and Tuscola counties.
#10	Ionia, Kent, Lake, Mason, Mecosta, Montcalm, Newaygo, and Osceola counties.
#11	Alcona, Arenac, Alpena, Cheboygan, Crawford, Iosco, Montmorency, Ogemaw, Oscoda, Otsego, Presque Isle, and Roscommon counties.
#12	Antrim, Benzie, Charlevoix, Emmet, Grand Traverse, Kalkaska, Leelanau, Manistee, Missaukee, and Wexford counties.

**#13** Alger, Baraga, Chippewa, Delta, Dickinson, Gogebic, Houghton, Iron, Keweenaw, Luce, Mackinac, Marquette, Menominee, Ontonagon, and Schoolcraft counties.

**#14** Muskegon, Oceana, and Ottawa counties.

(Note: The bill contains a typographical error: Gross Pointe Farms, instead of Grosse Pointe Farms.)
