# ENROLLED HOUSE BILL No. 5429

AN ACT to make appropriations for the department of natural resources and for local recreation grants for the fiscal year ending September 30 1994 to prescribe the powers and duties of certain state agencies and officials and to provide for the expenditure of the appropriations

## **GENERAL SECTIONS**

Sec 201 In accordance with the provisions of section 30 of article IX of the state constitution of 1963 total state spending in this appropriation act is \$11 945 900 00 and state appropriations to be paid to local units of government are \$11 945 900 00 as follows

Sec 202 The appropriations made and expenditures authorized under this act and the departments agencies commissions boards offices and programs for which an appropriation is made under this act are subject to the management and budget act Act No 431 of the Public Acts of 1984 being sections 18 1101 to 18 1594 of the Michigan Compiled Laws

Sec 203 For all projects and grant programs funded under this act the commission of natural resources or the department of natural resources shall notify each legislator whose district is to receive a grant 7 days before the grants are announced

Sec 204 (1) The unexpended portion of the appropriation in section 101 for local recreational grants projects in this act and Act No 55 of the Public Acts of 1990 Act No 194 of the Public Acts of 1990 Act No 30 of the Public Acts of 1991 Act No 83 of the Public Acts of 1992 and Act No 74 of the Public Acts of 1993 are considered work project appropriations and any unencumbered or unallotted funds are carried forward into the succeeding fiscal year The following is in compliance with section 451(3) of the management and budget act Act No 431 of the Public Acts of 1984 being section 18 1451 of the Michigan Compiled Laws

(2) For each of the projects described in subsection (1)

(a) The purpose of the local recreational grant to be carried forward is to improve the development of the state s recreational base

(b) The project will be accomplished by contract

(c) The total estimated costs of the project are identified m a line item appropriation

(d) The tentative completion date for the project is September 30 1997

This act is ordered to take immediate effect
