ENROLLED SENATE BILL No. 1101

AN ACT to amend sections 2 and 5 of Act No 237 of the Public Acts of 1992 entitled An act to authorize the state administrative board to convey certain state owned property m Lapeer county and to prescribe conditions for the conveyance and to repeal certain parts of the act

The People of the State of Michigan enact

Section 1 Sections 2 and 5 of Act No 237 of the Public Acts of 1992 are amended to read as follows

Sec 2 The state administrative board on behalf of the state may convey to the city of Lapeer for consideration of fair market value as determined pursuant to appraisal by the state tax commission or an independent fee appraiser certain parcels of property under the jurisdiction of the department of mental health which property is located in the city of Lapeer county Michigan and is more particularly described as follows

Parcel #4

Parcel #8

A parcel of land in the SW 1/4 of Section 6 T7N R10E Lapeer County Michigan and more particularly described as Commencing at the S1/4 corner of said Section 6 then N0 32 07 W 765 20 feet on the NS1/4 line of said Section 6 to the point of beginning of this description thence S55 08 02 W 431 22 feet thence N72 27 37 W 417 21 feet thence S76 24 35 W 375 78 feet thence N08 35 46 W 402 90 feet to the southerly right of way line of the Grand Trunk Western Railroad thence N74 23 55 E 1217 11 feet on said southerly right of way line to the NS1/4 line of said Section 6 thence S00 32 07 E 516 65 feet on said NS1/4 line to the point of beginning The above described parcel contains 13 68 acres more or less All bearings are relative and referenced to a previous survey by Fred J W Soll R L S #1090 in which observations of Polaris were taken The above described parcel is subject to any easements and/or r ghts of record as they may pertain to this parcel

Sec 5 The revenue received under this act shall be deposited in a restricted account and shall be appropriated only to the department of mental health

Section 2 Section 4 of Act No 237 of the Public Acts of 1992 is repealed
