



HOUSE BILL No. 4169

February 4, 1993, Introduced by Rep. Alley and referred to the Committee on State Affairs.

A bill to amend the title and sections 2 and 16 of Act No. 89 of the Public Acts of 1977, entitled as amended "State aid to public libraries act," section 2 as amended by Act No. 541 of the Public Acts of 1982, being sections 397.552 and 397.566 of the Michigan Compiled Laws; to repeal certain acts and parts of acts; and to repeal certain parts of the act.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. The title and sections 2 and 16 of Act No. 89 of
2 the Public Acts of 1977, section 2 as amended by Act No. 541 of
3 the Public Acts of 1982, being sections 397.552 and 397.566 of
4 the Michigan Compiled Laws, are amended to read as follows:

An act to provide for the establishment of cooperative libraries; to prescribe the powers and duties of the legislative council; to provide state aid for public libraries;

Sec. 2. As used in this act:

(A) "COOPERATIVE BOARD" MEANS THE GOVERNING BOARD OF THE COOPERATIVE LIBRARY.

(B) "COOPERATIVE LIBRARY" MEANS THE LIBRARY OR SERVICE CENTER DESIGNATED BY THE COOPERATIVE BOARD TO EXECUTE SERVICES ESTABLISHED BY THE COOPERATIVE PLAN AND PROVIDED TO LIBRARIES PARTICIPATING IN THE COOPERATIVE.

(C) "DISTRICT LIBRARY" MEANS A LIBRARY ESTABLISHED PURSUANT TO THE DISTRICT LIBRARY ESTABLISHMENT ACT, ACT NO. 24 OF THE PUBLIC ACTS OF 1989, BEING SECTIONS 397.171 TO 397.196 OF THE MICHIGAN COMPILED LAWS.

(D) ~~(a)~~ "Local board" means the board of trustees or directors that has ~~as~~ its primary purpose ~~the~~ supervision of a local public library ~~or~~ that board contracting for library service, or, if such a board does not exist, the legislative body of the local government ~~which~~ THAT maintains the public library.

(E) ~~(b)~~ "Local support" means funds from tax sources, gifts, endowments, penal fines, or other funds received from

1 local sources, excluding state and federal aid as ~~stated~~
2 PROVIDED in this act.

3 (F) ~~(c)~~ "Public library" means a library ~~which is~~ law-
4 fully established for free public purposes by 1 or more counties,
5 cities, townships, villages, school districts, or other local
6 governments or a combination thereof, or by a public or local
7 act, the entire interests of which belong to the general public.
8 ~~It~~ PUBLIC LIBRARY does not include a special library such as a
9 professional, technical, or school library.

10 ~~(d) "Cooperative board" means the governing board of the~~
11 ~~cooperative library.~~

12 ~~(e) "Cooperative library" means the library or service~~
13 ~~center designated by the cooperative board to execute services~~
14 ~~established by the cooperative plan and provided to libraries~~
15 ~~participating in the cooperative.~~

16 (G) ~~(f)~~ "State board" means the legislative council.

17 Sec. 16. ~~(1) A public library shall receive 35 cents per~~
18 ~~capita from state aid during the fiscal year 1977-78 if in the~~
19 ~~prior year the library received local support equal to that~~
20 ~~required by this act.~~

21 (1) ~~(2)~~ A public library shall receive 50 cents per capita
22 from state aid during ~~the~~ EACH fiscal year ~~+978-79~~ if in the
23 prior year the library received local support equal to that
24 required by this act ~~, the library has not reduced its local~~
25 ~~support by an amount equal to, or larger than, the state aid from~~
26 ~~the previous year without the approval of the state board, and~~

1 IF the library meets the minimum standards established by the
2 state board and this act.

3 ~~(3) A public library belonging to a cooperative library~~
4 ~~shall receive from state aid for the fiscal year 1977-78 an addi-~~
5 ~~tional 15 cents per capita, all or a part of which must be used~~
6 ~~to pay for cooperative services from the cooperative board as~~
7 ~~provided by section 15 and the cooperative plan.~~

8 (2) ~~(4)~~ A public library belonging to a cooperative
9 library shall receive from state aid each FISCAL year ~~after~~
10 ~~fiscal year 1977-78~~ an additional 50 cents per capita, all or
11 part of which shall be used to pay for cooperative services from
12 the cooperative board as provided by section 15 and the coopera-
13 tive plan. ~~When~~ AFTER the cost of the cooperative library
14 services ~~has been~~ IS paid, any remaining portion of the grant
15 may be applied to local services. ~~under subsection (2).~~ Each
16 ~~public library~~

17 (3) A cooperative ~~which~~ LIBRARY THAT qualifies under this
18 act ~~during fiscal year 1977-78 and following years~~ shall
19 receive ~~an amount of~~ FROM STATE AID EACH FISCAL YEAR \$10.00 per
20 square mile for the area ~~which it~~ THAT THE COOPERATIVE LIBRARY
21 serves if ~~the~~ THAT area ~~served~~ has less than 75 people per
22 square mile.

23 (4) ~~(5)~~ A public library ~~which~~ THAT is a county library
24 ~~serving~~ OR DISTRICT LIBRARY, THAT SERVES a population of 50,000
25 or less, ~~which~~ AND THAT appoints to the office of head librar-
26 ian a person with either a bachelor of arts or a bachelor of
27 science degree from a college or university approved by an

1 accrediting association of more than statewide standing,
 2 including or supplemented by 1 full year of training in a library
 3 school accredited by the American library association and with at
 4 least 4 years' experience in an administrative capacity in an
 5 approved library, shall be reimbursed for that portion of the
 6 salary not exceeding \$400.00 for any 1 month or \$4,800.00 ~~in~~
 7 FOR any 1 year, if, ~~the county library received~~ during the last
 8 completed fiscal year before the year in which distribution is to
 9 be made, THE PUBLIC LIBRARY RECEIVED from the county ~~or~~
 10 ~~counties~~ IF A COUNTY LIBRARY, FROM THE PARTICIPATING MUNICIPALI-
 11 TIES IF A DISTRICT LIBRARY, OR FROM A LIBRARY MILLAGE not less
 12 than \$3,600.00, ~~exclusive of~~ EXCLUDING money received from fed-
 13 eral or state grants in aid to the library. Wage increases to
 14 ~~present employees~~ INDIVIDUALS EMPLOYED AS OF AUGUST 2, 1977
 15 shall be paid equally by ~~the~~ THIS state and local ~~governments~~
 16 UNITS OF GOVERNMENT. Before September 6, December 6, March 6,
 17 and June 6 of the year of distribution, the ~~county library~~
 18 board OF THE COUNTY LIBRARY OR DISTRICT LIBRARY or the board's
 19 authorized agent shall certify to the state board the actual
 20 amount of the salary paid the head librarian during the 3-month
 21 period immediately preceding those months.
