

HOUSE BILL No. 4265

February 17, 1993, Introduced by Reps. Joe Young, Jr. and Murphy and referred to the Committee on State Affairs.

A bill to amend the title and sections 1, 2, and 3 of Act No. 222 of the Public Acts of 1989, entitled

"An act to authorize the state administrative board to convey certain state owned property in Grand Traverse county; to prescribe conditions for the conveyance; and to provide for the disposition of revenue derived from the conveyance,"

and to add section 1a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. The title and sections 1, 2, and 3 of Act
- 2 No. 222 of the Public Acts of 1989, are amended and section 1a is
- 3 added to read as follows:
- 4 TITLE
- 5 An act to authorize the state administrative board to convey
- 6 certain PARCELS OF state owned property in Grand Traverse county;
- 7 to prescribe conditions for the -conveyance CONVEYANCES; and to

- 1 provide for the disposition of revenue derived from the
- 2 -conveyance CONVEYANCES.
- 3 Sec. 1. The state administrative board, on behalf of the
- 4 state, may convey to O-C-T Oil, Inc., for not less than fair
- 5 market value as determined pursuant to section 2 property which
- 6 is now under the jurisdiction of the department of mental health,
- 7 being a portion of the C & O railroad property leading into
- 8 Traverse City psychiatric hospital in the city of Traverse City,
- 9 Grand Traverse county, Michigan, and more specifically described
- 10 as follows:
- Lots 1, 2, 3, Block 17, Hannah, Lay and Company's Second
- 12 Addition to Traverse City, Michigan, EXCLUDING THE WEST 55 FEET
- 13 OF LOTS 1, 2, 3, BLOCK 17, HANNAH, LAY AND COMPANY'S SECOND
- 14 ADDITION TO TRAVERSE CITY, MICHIGAN.
- 15 SEC. 1A. THE STATE ADMINISTRATIVE BOARD, ON BEHALF OF THE
- 16 STATE, MAY CONVEY TO WATSON PRINTING, INC., FOR NOT LESS THAN
- 17 FAIR MARKET VALUE AS DETERMINED PURSUANT TO SECTION 2, PROPERTY
- 18 THAT IS NOW UNDER THE JURISDICTION OF THE DEPARTMENT OF MENTAL
- 19 HEALTH, IS LOCATED ADJACENT TO THE PROPERTY DESCRIBED IN
- 20 SECTION 1, AND IS MORE SPECIFICALLY DESCRIBED AS FOLLOWS:
- 21 THE WEST 55 FEET OF LOTS 1, 2, 3, BLOCK 17, HANNAH, LAY AND
- 22 COMPANY'S SECOND ADDITION TO TRAVERSE CITY, MICHIGAN.
- Sec. 2. The fair market value of the PARCELS OF property
- 24 described in -section SECTIONS 1 AND 1A shall be determined by
- 25 an appraisal based on the property's highest and best use, as
- 26 prepared by the state tax commission.

Sec. 3. The conveyance— CONVEYANCES authorized in

2 -section— SECTIONS 1 AND 1A shall be by quitclaim deed approved

3 by the attorney general and shall reserve to the state all rights

4 to coal, oil, gas, and other materials, excluding sand, gravel,

5 clay, or other nonmetallic minerals found on, within, or under

6 the conveyed lands.
