

HOUSE BILL No. 4354

February 24, 1993, Introduced by Reps. Bodem, Jaye and Gernaat and referred to the Committee on State Affairs.

A bill to authorize the state administrative board to convey certain state owned property and relinquish a certain easement in Cheboygan county; to prescribe conditions for the conveyance; and to provide for disposition of the revenue derived from the conveyance.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. The state administrative board, on behalf of the
- 2 state, may convey to the city of Cheboygan, for consideration of
- 3 \$1.00, property under the jurisdiction of the department of natu-
- 4 ral resources and located in the city of Cheboygan, Cheboygan
- 5 county, Michigan, and further described as follows:
- 6 That part of the SE1/4 of Section 31, T38N, R1W, City of
- 7 Cheboygan lying easterly of the Cheboygan River and westerly of a
- 8 line commencing at a point on the east and west one-quarter line
- 9 that is 292.48 feet west of a point that would be created by the

- 1 west line of South Street extended, thence S 29°48'W 297.64 feet,
- 2 thence S 33°44'W 153.48 feet, thence S 56°16'E 33 feet, thence S
- 3 33°44'W 72.08 feet, thence S 23°38'W 101.71 feet, thence N 24°27'
- 4 W 44.35 feet, thence S 15°31'40" W 166.34 feet, thence S 4°8'20"
- 5 W 121.78 feet, thence S 41°01'E 253.54 feet to point of ending.
- 6 Sec. 2. As part of the conveyance authorized under this
- 7 act, the state administrative board, on behalf of the state, also
- 8 shall relinquish a certain 33-foot easement particularly
- 9 described as follows:
- Beginning at a point on the West line of South Street
- 11 extended that is N 02°26'E 1,868.96 feet from South line of
- 12 Section 31, T38N R1W, thence N 85°34'W 461.78 feet, thence N
- 13 24°27'W 206.84 feet, thence N 23°38'E 44.35 feet, thence S
- 14 24°27'E 216.99 feet, thence S 85°34'E 441.15 feet to West line of
- 15 South Street extended, thence S 02°26'W along said line 33.02
- 16 feet to beginning.
- 17 Sec. 3. (1) The conveyance authorized by this act shall
- 18 provide for both of the following:
- (a) That the property conveyed shall be used for a public
- 20 park.
- 21 (b) That the city of Cheboygan shall provide free access
- 22 across the property to persons for the purpose of public fishing,
- 23 24 hours per day, 7 days per week.
- 24 (2) The conveyance authorized by this act shall provide that
- 25 upon termination of the use described in subsection (1), or upon
- 26 use for any other purpose, title to the property shall revert

- 1 immediately to the state, with the state assuming no liability
- 2 for any improvements made by the grantee.
- 3 Sec. 4. The conveyance authorized by this act also shall
- 4 provide that the city of Cheboygan shall be responsible for main-
- 5 taining the gabion and stairway on the property conveyed.
- 6 Sec. 5. The conveyance authorized by this act shall be by
- 7 quitclaim deed approved by the attorney general and shall reserve
- 8 to the state all rights to coal, oil, gas, and other nonmetallic
- 9 minerals found on or under the property conveyed. The relin-
- 10 guishment of the easement under section 2 shall be by instrument
- 11 approved by the attorney general.
- 12 Sec. 6. The revenue received under this act shall be depos-
- 13 ited in the state treasury and credited to the general fund.
