



# HOUSE BILL No. 4537

March 24, 1993, Introduced by Reps. Joe Young, Jr. and Joe Young, Sr. and referred to the Committee on Education.

A bill to amend Act No. 94 of the Public Acts of 1979, entitled as amended

"The state school aid act of 1979,"

as amended, being sections 388.1601 to 388.1772 of the Michigan Compiled Laws, by adding section 10.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1 Section 1. Act No. 94 of the Public Acts of 1979, as  
2 amended, being sections 388.1601 to 388.1772 of the Michigan  
3 Compiled Laws, is amended by adding section 10 to read as  
4 follows:

5 SEC. 10. (1) BEGINNING IN THE 1995-96 FISCAL YEAR, ALL DIS-  
6 TRICTS SHALL BE FUNDED AS IF THERE WERE A SINGLE STATEWIDE SCHOOL  
7 DISTRICT AND, SUBJECT TO SUBSECTION (2), EACH DISTRICT SHALL BE  
8 ALLOCATED A TOTAL ALLOCATION UNDER THIS ACT OF \$7,000.00 PER  
9 MEMBERSHIP PUPIL.

1 (2) IN ORDER TO RECEIVE THE ALLOCATION UNDER SUBSECTION (1),  
2 A DISTRICT SHALL COMPLY WITH SECTION 11 OF ARTICLE VIII OF THE  
3 STATE CONSTITUTION OF 1963 AND THE DISTRICT SHALL SUBMIT TO THE  
4 STATE BOARD FOR APPROVAL A PROPOSED BUDGET FOR THE 1995-96 FISCAL  
5 YEAR SHOWING HOW THE ALLOCATION WILL BE EXPENDED. THE STATE  
6 BOARD SHALL APPROVE A DISTRICT'S PROPOSED BUDGET AND THE DISTRICT  
7 SHALL RECEIVE ITS ALLOCATION ONLY IF THE STATE BOARD FINDS THAT  
8 THE PROPOSED BUDGET WILL ENSURE THAT AT LEAST \$5,000.00 PER MEM-  
9 BERSHIP PUPIL OF THE ALLOCATION WILL BE EXPENDED FOR EQUIPMENT,  
10 FACILITIES, AND SERVICES TO DIRECTLY BENEFIT PUPILS' EDUCATION  
11 AND THAT NOT MORE THAN \$2,000.00 PER MEMBERSHIP PUPIL OF THE  
12 ALLOCATION WILL BE EXPENDED FOR TEACHER AND ADMINISTRATOR  
13 SALARIES.

14 Section 2. This amendatory act shall not take effect unless  
15 Senate Joint Resolution \_\_\_\_\_ or House Joint Resolution  
16 N (request no. 02031'93<sup>\*</sup>) of the 87th Legislature is sub-  
17 mitted to the qualified electors of the state for approval as  
18 provided in section 1 of article XII of the state constitution of  
19 1963.
