

## **HOUSE BILL No. 4608**

April 20, 1993, Introduced by Reps. Hammerstrom, Rivers, Llewellyn, Oxender, Hollister and Shugars and referred to the Committee on Consumers.

A bill to amend section 1 of Act No. 87 of the Public Acts of 1986, entitled

"An act regarding warranties on new motor vehicles; to require certain repairs thereto; and to provide remedies for the failure to repair such vehicles,"

being section 257.1401 of the Nichigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 1 of Act No. 87 of the Public Acts of
- 2 1986, being section 257.1401 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 1. As used in this act:
- 5 (a) "Consumer" means any of the following, but does not
- 6 include a lessee of a new motor vehicle:
- 7 (i) A person who purchases a new motor vehicle for personal,
- 8 family, or household use and not for the purpose of selling or
- 9 leasing the new motor vehicle to another person.

- (ii) A person who purchases less than 10 new motor vehicles2 a year.
- 3 (iii) A person who purchases 10 or more new motor vehicles a
- 4 year only if the vehicles are purchased for personal, family, or
- 5 household use.
- 6 (iv) Any other person entitled to enforce the provisions of7 an express warranty pursuant to the terms of that warranty.
- 8 (b) "Manufacturer" means any person who manufactures, assem-
- 9 bles, or is a distributor of new motor vehicles and includes an
- 10 agent of a manufacturer but does not include a new motor vehicle
- 11 dealer.
- (c) "Manufacturer's express warranty" means an express war-
- 13 ranty as determined under the uniform commercial code, Act
- 14 No. 174 of the Public Acts of 1962, being sections 440.1101 to
- 15 440.11102 of the Michigan Compiled Laws, offered by the manufac-
- 16 turer on a new motor vehicle.
- (d) "Motor vehicle" means a motor vehicle as defined in
- 18 section 33 of the Michigan vehicle code, Act No. 300 of the
- 19 Public Acts of 1949, being section 257.33 of the Michigan
- 20 Compiled Laws, that is designed as a passenger vehicle, OR A
- 21 MOTORCYCLE AS DEFINED IN SECTION 31 OF THE MICHIGAN VEHICLE CODE,
- 22 ACT NO. 300 OF THE PUBLIC ACTS OF 1949, BEING SECTION 257.31 OF
- 23 THE MICHIGAN COMPILED LAWS, but does not include a motor home,
- 24 bus, truck other than a pickup truck or van, or any vehicle,
- 25 EXCEPT A MOTORCYCLE, designed to travel on less than 4 wheels.
- 26 (e) "New motor vehicle" means a motor vehicle that is
- 27 purchased in this state or purchased by a resident of this state

- 1 and is covered by a manufacturer's express warranty at the time
  2 of purchase.
- 3 (f) "New motor vehicle dealer" means a person who holds a
- 4 dealer agreement for the sale of new motor vehicles, who is
- 5 engaged in the business of purchasing, selling, exchanging, or
- 6 dealing in new motor vehicles, and who has an established place
- 7 of business in this state; and an agent thereof OF THAT
- 8 PERSON.
- 9 (g) "Person" means a natural person, or a sole proprietor-
- 10 ship, partnership, corporation, association, unit or agency of
- 11 government, trust, estate, or other legal entity.
- (h) "Resident of this state" means as follows:
- (i) For an individual, that the individual is a legal resi-
- 14 dent of this state.
- (ii) For a sole proprietorship or partnership, that the sole
- 16 proprietorship or partnership was created pursuant to the laws of
- 17 this state and its main office is located in this state.
- 18 (iii) For a corporation, that the corporation is considered
- 19 to be a domestic corporation and was created under the laws of
- 20 this state.
- 21 (iv) For an association, that the association was created
- 22 pursuant to the laws of this state and its main office is located
- 23 in this state.
- 24 ( $\nu$ ) For a unit or agency of government, that the unit or
- 25 agency is located in this state.

- (vi) For a trust, estate, or other legal entity, that the
- 2 trust, estate, or other legal entity was created pursuant to the
- 3 laws of this state and is located in this state.
