

## **HOUSE BILL No. 4760**

May 11, 1993, Introduced by Reps. Bobier, Anthony, Middaugh, Dolan, Bodem, Allen, Gnodtke, Sikkema, Nye, McManus, Goschka, Lowe, Hill, Rhead, Alley, Brown, Porreca, Wetters, Shepich, Yokich, Profit, Dalman, Wallace, DeMars, Palamara, Llewellyn, Brackenridge, Gernaat, Stille, McBryde and Middleton and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend section 439 of Act No. 281 of the Public Acts of 1967, entitled

"Income tax act of 1967,"

as amended by Act No. 286 of the Public Acts of 1986, being section 206.439 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 439 of Act No. 281 of the Public Acts of
- 2 1967, as amended by Act No. 286 of the Public Acts of 1986, being
- 3 section 206.439 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 439. (1) Effective for tax years beginning in 1983
- 6 through -1994 1999, or until the state treasurer certifies that
- 7 the assets in the nongame fish and wildlife trust fund created in
- 8 the nongame fish and wildlife trust fund act exceed
- 9 \$6,000,000.00, whichever occurs first, a taxpayer who is entitled

- I to a tax refund under this act sufficient to make a designation
- 2 under this section may designate that \$2.00 or more of his or her
- 3 refund be credited to the state of Michigan nongame fish and
- 4 wildlife trust fund CREATED IN THE NONGAME FISH AND WILDLIFE
- 5 TRUST FUND ACT, ACT NO. 285 OF THE PUBLIC ACTS OF 1986, BEING
- 6 SECTIONS 299.151 TO 299.161 OF THE MICHIGAN COMPILED LAWS.
- 7 (2) The tax designation authorized in this section shall be
- 8 clearly and unambiguously printed on the first page of all state
- 9 individual income tax return forms, if practicable.
- 10 (3) Notwithstanding the other allocations and disbursements
- 11 required by this act, an amount equal to the cumulative designa-
- 12 tions made under this section, less the amount appropriated to
- 13 the department of treasury for the purpose of implementing this
- 14 section, shall be deposited in the state of Michigan nongame fish
- 15 and wildlife trust fund and shall be appropriated solely for the
- 16 purposes of the fund.
