

## **HOUSE BILL No. 4912**

July 1, 1993, Introduced by Reps. Curtis, Yokich, Mathieu and Nye and referred to the Committee on Judiciary.

A bill to amend section 27 of Act No. 5 of the Public Acts of 1956, entitled as amended

"Michigan uniform municipal court act,"

being section 730.527 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 27 of Act No. 5 of the Public Acts of
- 2 1956, being section 730.527 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- Sec. 27. When IF a warrant has been issued by a judge of
- 5 the municipal court of any city affected by the provisions of
- 6 this act for a criminal offense, not cognizable by a justice
- 7 of the peace, the person charged with -such THAT offense may be
- 8 -brought before ARRAIGNED BY any judge of -such THAT municipal
- 9 court. -, who THE JUDGE may fix the amount of bail or let

1 -such THE person to bail, or both, and set a date for the
 2 examination provided by law before the judge who signed -such-
 3 THE warrant. -, and if IF the person charged with -such THE
 4 offense -shall waive WAIVES examination, -he- THE JUDGE may fix
 5 the amount of bail or let -him- THE PERSON to bail, or both, and
 6 bind -him THE PERSON to appear before the circuit court of the
 7 county or any court having jurisdiction of -said THAT cause for
 8 trial. -, provided the offense is one for which a justice of the
 9 peace has power to let to bail. When IF a warrant has been
10 issued by -any such A municipal judge for an offense against the
11 laws of the THIS state of Michigan cognizable by a justice of
12 the peace and the person charged has been arraigned and the
13 amount of bail has been set, a recognizance for the appearance of
14 the person charged to answer for -such- THAT offense may be taken
15 and entered into by any clerk or deputy clerk of -such THAT
