A bill to amend Act No. 24 of the Public Acts of 1989, enti-

"The district library establishment act,"

being sections 397.171 to 397.196 of the Michigan Compiled Laws, by adding section 13a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 24 of the Public Acts of 1989, being
- 2 sections 397.171 to 397.196 of the Michigan Compiled Laws, is
- 3 amended by adding section 13a to read as follows:
- 4 SEC. 13A. (1) THE FISCAL YEAR OF A DISTRICT LIBRARY SHALL
- 5 BEGIN JULY 1 OR DECEMBER 1, AS DETERMINED BY THE BOARD. THE
- 6 BOARD SHALL PROVIDE BY RESOLUTION FOR COLLECTION OF A DISTRICT-
- 7 WIDE TAX, AS PROVIDED IN THIS SECTION.
- 8 (2) TO THE EXTENT APPLICABLE AND CONSISTENT WITH THIS
- 9 SECTION, THE PROVISIONS OF THE GENERAL PROPERTY TAX ACT, ACT

- 1 NO. 206 OF THE PUBLIC ACTS OF 1893, BEING SECTIONS 211.1 TO
- 2 211.157 OF THE MICHIGAN COMPILED LAWS, APPLY TO THE ASSESSMENT,
- 3 SPREADING, AND COLLECTION OF A DISTRICTWIDE TAX AND TO THE POWERS
- 4 AND DUTIES OF THE TOWNSHIP SUPERVISOR, TOWNSHIP CLERK, AND TOWN-
- 5 SHIP TREASURER. THE CITY ASSESSING OFFICER, CITY CLERK, AND CITY
- 6 TREASURER OF A CITY IN WHICH ALL OR PART OF A DISTRICT IS LOCATED
- 7 HAVE THE SAME POWERS AND DUTIES WITH RESPECT TO THE ASSESSMENT,
- 8 SPREADING, AND COLLECTION OF A DISTRICTWIDE TAX WITHIN THE CITY
- 9 AS A TOWNSHIP SUPERVISOR, TOWNSHIP CLERK, AND TOWNSHIP TREASURER
- 10 HAVE WITH RESPECT TO THE ASSESSMENT, SPREADING, AND COLLECTION OF
- 11 A DISTRICTWIDE TAX WITHIN A TOWNSHIP.
- 12 (3) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (4), A DIS-
- 13 TRICTWIDE TAX SHALL BE LEVIED AND COLLECTED BY EACH CITY AND
- 14 TOWNSHIP IN WHICH ALL OR PART OF A DISTRICT IS LOCATED AT THE
- 15 SAME TIME AT WHICH THE TAXES OF THE CITY OR TOWNSHIP ARE LEVIED
- 16 AND COLLECTED. A DISTRICTWIDE TAX COLLECTED BY A CITY OR TOWN-
- 17 SHIP BECOMES A LIEN AGAINST THE PROPERTY ON WHICH ASSESSED IN THE
- 18 SAME MANNER AND ON THE SAME DATE AS THE CITY OR TOWNSHIP TAXES,
- 19 AND IS SUBJECT TO THE SAME PENALTIES, INTEREST, AND COLLECTION
- 20 CHARGES AS THE CITY OR TOWNSHIP TAXES, AND SHALL BE RETURNED AS
- 21 DELINQUENT TO THE COUNTY TREASURER OR COUNTY TREASURERS IN THE
- 22 SAME MANNER AND WITH THE SAME INTEREST, PENALTIES, AND FEES AS
- 23 THE CITY OR TOWNSHIP TAXES ARE RETURNED.
- 24 (4) IF A SCHOOL DISTRICT IS A PARTICIPATING MUNICIPALITY,
- 25 EACH CITY OR TOWNSHIP THAT COLLECTS SCHOOL TAXES FOR THE SCHOOL
- 26 DISTRICT ON A SUMMER LEVY SHALL LEVY AND COLLECT THE DISTRICT
- 27 LIBRARY DISTRICTWIDE TAX AT THE SAME TIME AT WHICH SCHOOL TAXES

- 1 ARE LEVIED AND COLLECTED FOR THE SUMMER TAX LEVY, IF SPECIFIED BY
- 2 THE DISTRICT LIBRARY. IF TAXES ARE COLLECTED ON A SUMMER TAX
- 3 LEVY, ALL OF THE FOLLOWING SHALL APPLY:
- 4 (A) TAXES AUTHORIZED TO BE COLLECTED SHALL BECOME A LIEN
- 5 AGAINST THE PROPERTY ON WHICH ASSESSED, AND DUE FROM THE OWNER OF
- 6 THAT PROPERTY, ON JULY 1.
- 7 (B) TAXES SHALL BE COLLECTED ON OR BEFORE SEPTEMBER 14 AND
- 8 ALL TAXES AND INTEREST IMPOSED PURSUANT TO SUBDIVISION (C) UNPAID
- 9 BEFORE MARCH 1 SHALL BE RETURNED AS DELINQUENT ON MARCH 1. TAXES
- 10 DELINQUENT UNDER THIS SUBDIVISION SHALL BE COLLECTED PURSUANT TO
- 11 ACT NO. 206 OF THE PUBLIC ACTS OF 1893.
- 12 (C) INTEREST SHALL BE ADDED TO TAXES COLLECTED AFTER
- 13 SEPTEMBER 14 AT THAT RATE IMPOSED BY SECTION 59 OF ACT NO. 206 OF
- 14 THE PUBLIC ACTS OF 1893, BEING SECTION 211.59 OF THE MICHIGAN
- 15 COMPILED LAWS, ON DELINQUENT PROPERTY TAX LEVIES THAT BECAME A
- 16 LIEN IN THE SAME YEAR.
- 17 (D) ALL OR A PORTION OF FEES OR CHARGES, OR BOTH, AUTHORIZED
- 18 UNDER SECTION 44 OF ACT NO. 206 OF THE PUBLIC ACTS OF 1893, BEING
- 19 SECTION 211.44 OF THE MICHIGAN COMPILED LAWS, MAY BE IMPOSED ON
- 20 TAXES PAID BEFORE MARCH 1.
- 21 (5) INTEREST AND PENALTIES IMPOSED ON TAXES COLLECTED PURSU-
- 22 ANT TO THIS SECTION, OTHER THAN PROPERTY TAX ADMINISTRATION FEES,
- 23 THAT ARE IMPOSED BEFORE THE DATE THE TAXES ARE RETURNED DELIN-
- 24 OUENT AND THAT ARE ATTRIBUTABLE TO A DISTRICT LIBRARY DISTRICT-
- 25 WIDE TAX BELONG TO THE DISTRICT LIBRARY.
