A bill to amend Act No. 280 of the Public Acts of 1939, entitled as amended

"The social welfare act,"

as amended, being sections 400.1 to 400.119b of the Michigan Compiled Laws, by adding section 117.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 280 of the Public Acts of 1939, as
- 2 amended, being sections 400.1 to 400.119b of the Michigan
- 3 Compiled Laws, is amended by adding section 117 to read as
- 4 follows:
- 5 SEC. 117. (1) THE CHILD WELFARE TRAINING REVOLVING FUND IS
- 6 CREATED IN THE STATE TREASURY. THE FUND SHALL BE ADMINISTERED BY
- 7 THE DEPARTMENT AND SHALL BE USED ONLY AS PRESCRIBED IN THIS
- 8 SECTION.

- 1 (2) THE STATE TREASURER SHALL CREDIT TO THE FUND ALL AMOUNTS
- 2 APPROPRIATED FOR THAT PURPOSE FROM FEDERAL FUNDS. THE STATE
- 3 TREASURER SHALL DIRECT THE INVESTMENT OF THE FUND. EARNINGS
- 4 SHALL BE CREDITED TO THE FUND.
- 5 (3) ANY MONEY, INCLUDING INTEREST EARNED BY THE FUND.
- 6 REMAINING IN THE FUND AT THE END OF A FISCAL YEAR SHALL BE CAR-
- 7 RIED OVER IN THE FUND TO THE NEXT AND SUCCEEDING FISCAL YEARS AND
- 8 SHALL NOT BE CREDITED TO OR REVERT TO THE GENERAL FUND.
- 9 (4) THE DEPARTMENT SHALL USE THE MONEY IN THE FUND TO PRO-
- 10 VIDE SPECIALIZED TRAINING FOR CHILD PROTECTIVE SERVICE WORKERS,
- 11 FOSTER PARENTS, AND ADOPTIVE PARENTS PURSUANT TO A TRAINING PLAN
- 12 APPROVED BY THE FEDERAL GOVERNMENT PURSUANT TO TITLE IV OF THE
- 13 SOCIAL SECURITY ACT, CHAPTER 531, 49 STAT. 620, 42 U.S.C. 601 TO
- 14 603, 604 TO 610, 612 TO 613, 615 TO 617, 620 TO 628, 651 TO 669,
- 15 670 TO 677, 679, AND 681 TO 687.
