A bill to make appropriations for the department of natural resources and for local recreation grants for the fiscal year ending September 30, 1994 to prescribe the powers and duties of certain state agencies and officials and to provide for the expenditure of the appropriations

 22 this act and the departments, agencies, commissions, boards, offices and
 23 programs for which an appropriation is made under this act are subject to
 24 the management and budget act, Act No 431 of the Public Acts of 1984
 25 being sections 18 1101 to 18 1594 of the Michigan Compiled Laws

1 Sec 203 For all projects and grant programs funded under this
2 act, the commission of natural resources or the department of natural
3 resources shall notify each legislator whose district is to receive a
4 grant 7 days before the grants are announced

5 Sec 204 (1) The unexpended portion of the appropriation in sec-
6 tion 101 for local recreational grants projects in this act and Act
7 No 55 of the Public Acts of 1990, Act No 194 of the Public Acts of
8 1990, Act No 30 of the Public Acts of 1991, Act No 83 of the Public
9 Acts of 1992, and Act No 74 of the Public Acts of 1993 are considered
10 work project appropriations and any unencumbered or unallotted funds are
11 carried forward into the succeeding fiscal year The following is in
12 compliance with section 451(3) of the management and budget act, Act
13 No 431 of the Public Acts of 1984, being section 18 1451 of the Michigan
14 Compiled Laws
