THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Section 181 of Act No 303 of the Public Acts of
- 2 1967 as added by Act No 301 of the Public Acts of 1992, being
- 3 section 281 1181 of the Michigan Compiled Laws, is amended and
- 4 section 22a is added to read as follows
- 5 SEC 22A IN ADDITION TO COMPLYING WITH SECTION 22, THE
- 6 DEPARTMENT SHALL DEVELOP AND PROVIDE A BOATING SAFETY EDUCATION
- 7 PROGRAM FOR PERSONS CONVICTED OF A VIOLATION OF SECTION 171 OR A
- 8 LOCAL ORDINANCE SUBSTANTIALLY COMPLYING WITH SECTION 171 THE
- 9 PROGRAM SHALL INCLUDE AT LEAST 1 PRESENTATION BY A VICTIM

- 24 whether the person INDIVIDUAL is likely to benefit from reha-
- 25 bilitative services, including alcohol or drug education or
- 26 treatment programs

- 1 (B) COMPLETE A MARINE SAFETY EDUCATION COURSE DESCRIBED IN 2 SECTION 22A
- 3 (3) As part of the sentence FOR A VIOLATION DESCRIBED IN
- 4 THIS SECTION, the court may order the person to participate in
- 5 and successfully complete 1 or more appropriate rehabilitative
- 6 programs The person shall pay for the costs of the screening,
- 7 assessment, and rehabilitative services
