THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Section 1026 of Act No 451 of the Public Acts
- 2 of 1976, as amended by Act No 203 of the Public Acts of 1983,
- 3 being section 380 1026 of the Michigan Compiled Laws, is amended
- 4 and section 1026a is added to read as follows
- 5 Section— SEC 1026 (1) The same question or measure
- 6 involving consolidation of school districts, annexation of entire
- 7 school districts, OR annexation or transfer of a portion of 1
- 8 school district to another -, or bonding of school districts,

- 1 except bonding for the funding of operating deficits as
- 2 authorized by section +356 shall not be submitted to the school
- 3 electors of a SCHOOL district more often than once in 6 months,
- 4 unless the board is presented with a petition requesting the

- 17 THE SAME PROPOSAL FOR AUTHORIZATION TO INCREASE SCHOOL OPERATING
- 18 MILLAGE, FOR AUTHORIZATION TO RENEW SCHOOL OPERATING MILLAGE OF
- 19 FOR AUTHORIZATION TO BORROW MONEY AND ISSUE BONDS OR NOTES OF THE
- 20 DISTRICT TO REPAY ALL OR PART OF THE MONEY BORROWED
