THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- f Section 1 The title of Act No 44 of the Public Acts of

- 5 TITLE
- 6 An act to provide purity and quality standards for motor
- 7 fuels to regulate the transfer sale, dispensing or offering
- 8 motor fuels for sale to provide for an inspection and testing
- 9 program TO REQUIRE CERTAIN ADDITIVES IN CERTAIN AUTOMOTIVE

- 1 PRODUCTS to provide for the powers and duties of certain state
- 2 agencies to provide for the licensing of certain persons engaged
- 3 in the transfer, sale, dispensing, or offering of motor fuels for
- 4 sale to regulate stage I and stage II vapor-recovery systems at
- 5 certain facilities to provide for fees and to provide remedies
- 6 and prescribe penalties
- 7 SEC 3A (1) AS USED IN THIS SECTION
- 8 (A) 'AUTOMOTIVE PRODUCT MEANS ENGINE COOLANT OR ANTIFREEZE
- 9 PREDILUTED ENGINE COOLANT OR PREDILUTED ANTIFREEZE, BRAKE FLUID,
- 10 AUTOMATIC TRANSMISSION FLUID, OR ANY EXTERNAL AUTOMOTIVE CLEANING
- 11 PRODUCT THAT CONTAINS MORE THAN 46 METHYL ALCOHOL
- 12 (B) "ENGINE COOLANT" OR "ANTIFREEZE' MEANS ANY SUBSTANCE OR
- 13 PREPARATION, REGARDLESS OF ITS ORIGIN, INTENDED TO BE DILUTED
- 14 BEFORE USE AS THE COOLING MEDIUM IN THE COOLING SYSTEM OF AN
- 15 INTERNAL COMBUSTION ENGINE TO PROVIDE PROTECTION AGAINST FREEZ-
- 16 ING, OVERHEATING, AND CORROSION OF THE COOLING SYSTEM, OR ANY
- 17 PRODUCT INTENDED TO BE DILUTED BEFORE USE WHICH IS LABELED TO
- 18 INDICATE OR IMPLY THAT IT WILL PREVENT FREEZING OR OVERHEATING OF
- 19 THE COOLING SYSTEM OF AN INTERNAL COMBUSTION ENGINE
- 20 (C) "PREDILUTED ENGINE COOLANT OR PREDILUTED ANTIFREEZE
- 21 MEANS ANY SUBSTANCE OR PREPARATION, REGARDLESS OF ITS ORIGIN,
- 22 INTENDED FOR USE FULL STRENGTH AS THE COOLING MEDIUM IN THE COOL-
- 23 ING SYSTEM OF AN INTERNAL COMBUSTION ENGINE TO PROVIDE PROTECTION
- 24 AGAINST FREEZING, OVERHEATING, AND CORROSION OF THE COOLING
- 25 SYSTEM, OR ANY SUBSTANCE OR PREPARATION INTENDED FOR USE FULL
- 26 STRENGTH WHICH IS LABELED TO INDICATE OR IMPLY THAT IT WILL

- 1 PREVENT OVERHEATING OR FREEZING OF THE COOLING SYSTEM OF AN
- 2 INTERNAL COMBUSTION ENGINE
- 3 (2) ANY ENGINE COOLANT OR ANTIFREEZE SOLD IN THIS STATE
- 4 AFTER JULY 1, 1995, THAT IS MANUFACTURED AFTER JANUARY 1, 1995,
- 5 AND THAT CONTAINS MORE THAN 10% ETHYLENE GLYCOL SHALL INCLUDE
- 6 DENATONIUM BENZOATE AT A MINIMUM OF 30 PARTS PER MILLION AS A
- 7 BITTERING AGENT WITHIN THE PRODUCT SO AS TO RENDER IT
- 8 UNPALATABLE ANOTHER BITTERING AGENT MAY BE USED IF IT PROVIDES
- 9 AN EQUIVALENT LEVEL OF BITTERNESS ANY MANUFACTURER OF A PRODUCT
- 10 SUBJECT TO THIS SUBSECTION SHALL CERTIFY IN WRITING TO THE
- 11 DEPARTMENT THE TRADE NAME, SCIENTIFIC NAME, AND ACTIVE INGREDI-
- 12 ENTS OF ANY BITTERING AGENT USED PURSUANT TO THIS SUBSECTION NOT
- 13 LATER THAN 30 DAYS AFTER THE AGENT HAS BEEN INCLUDED IN THE
- 14 PRODUCT
- 15 (3) ANY OTHER AUTOMOTIVE PRODUCT SOLD IN THIS STATE AFTER
- 16 JULY 1, 1995, THAT IS MANUFACTURED AFTER JANUARY 1, 1995 AND
- 17 CONTAINS MORE THAN 4 METHYL ALCOHOL THAT IS NOT FORMULATED AS A
- 18 MOTOR VEHICLE FUEL SHALL CONTAIN DENATONIUM BENZOATE AT A MINIMUM
- 19 OF 30 PARTS PER MILLION AS A BITTERING AGENT WITHIN THE PRODUCT
- 20 SO AS TO RENDER IT UNPALATABLE ANOTHER BITTERING AGENT MAY BE
- 21 USED IF IT PROVIDES AN EQUIVALENT LEVEL OF BITTERNESS ANY MANU-
- 22 FACTURER OF AN AUTOMOTIVE PRODUCT SUBJECT TO THIS SUBSECTION
- 23 SHALL CERTIFY IN WRITING TO THE DEPARTMENT THE TRADE NAME, SCIEN-
- 24 TIFIC NAME, AND ACTIVE INGREDIENTS OF ANY BITTERING AGENT USED
- 25 PURSUANT TO THIS SUBSECTION NOT LATER THAN 30 DAYS AFTER THE
- 26 AGENT HAS BEEN INCLUDED IN THE PRODUCT
