A bill to amend section 4 of Act No 192 of the Public Acts of 1953, entitled

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 14 (F) THE FUNDING RECEIVED
- 15 (G) THE DISBURSEMENTS MADE
