- 5 SEC 48 (1) A CANDIDATE INDEPENDENT POLITICAL POLITICAL
- 6 PARTY OR BALLOT QUESTION COMMITTEE THAT PAYS FOR A RADIO, TELE-
- 7 VISION, OR PRINT ADVERTISEMENT THAT REFERS DIRECTLY OR
- 8 INDIRECTLY, TO A CANDIDATE OR BALLOT QUESTION SHALL PREPARE AN
- 9 AFFIDAVIT RELATING TO THAT ADVERTISEMENT AND FILE THE AFFIDAVIT

- 23 THAN \$1,000 00 A MEDIA CONSULTANT THAT CAUSES THE BROADCAST OR
- 24 PUBLICATION OF AN ADVERTISEMENT FOR A COMMITTEE THAT IS FALSE IS
- 25 SUBJECT TO A CIVIL FINE OF NOT MORE THAN \$1,000 00 FOR EACH
- 26 BROADCAST OR PUBLICATION OF THAT ADVERTISEMENT

- 2 DAMAGES FOR CONDUCT PROSCRIBED UNDER THIS SECTION UNDER ANY OTHER
