THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Section 22209 of Act No 368 of the Public Acts
- 2 of 1978, as amended by Act No 88 of the Public Acts of 1993,
- 3 being section 333 22209 of the Michigan Compiled Laws, is amended
- 4 to read as follows
- 5 Sec 22209 (1) Except as otherwise provided in this part,
- 6 a person shall not do any of the following without first obtain-
- 7 ing a certificate of need

- 1 (a) Acquire an existing health facility or begin operation
 2 of a health facility at a site that is not currently licensed for
 3 that type of health facility
- 4 (b) Make a change in the bed capacity of a health facility
- 5 (c) Initiate replace, or expand a covered clinical
- 6 service
- 7 (d) Make a covered capital expenditure
- 8 (2) A certificate of need is not required for a reduction in
- 9 licensed bed capacity or services at a licensed site
- 10 (3) SUBSECTION (1)(D) DOES NOT APPLY TO A HOSPITAL LOCATED
- 11 IN A COUNTY WITH A POPULATION OF FEWER THAN 100,000
- 12 (4) -(3) An applicant seeking a certificate of need for the
- 13 acquisition of an existing health facility may file a single,
- 14 consolidated application for the certificate of need if the
- 15 project results in the acquisition of an existing health facility
- 16 but does not result in an increase or relocation of licensed beds
- 17 or the initiation expansion or replacement of a covered clini-
- 18 cal service Except as otherwise provided in this subsection, a
- 19 person acquiring an existing health facility is subject to the
- 20 applicable certificate of need review standards in effect on the
- 21 date of the transfer for the covered clinical services provided
- 22 by the acquired health facility The department may except 1 or
- 23 more of the covered clinical services listed in section
- 24 22203(10)(b), except the covered clinical service listed in sec-
- 25 tion 22203(10)(b)($\iota\nu$), from the minimum volume requirements in
- 26 the applicable certificate of need review standards in effect on
- 27 the date of the transfer if the equipment used in the covered

- 1 clinical service is unable to meet the minimum volume
- 2 requirements due to the technological incapacity of the
- 3 equipment A covered clinical service excepted by the department
- 4 under this subsection is subject to all the other provisions in
- 5 the applicable certificate of need review standards in effect on
- 6 the date of the transfer, except minimum volume requirements
- 7 ($^{\prime}$) $\frac{(4)}{(4)}$ The center for rural health created in
- 8 section 2612 shall designate a certificate of need ombudsman to
- 9 provide technical assistance and consultation to hospitals and
- 10 communities located in rural counties regarding certificate of
- 11 need proposals and applications under this part The ombudsman
- 12 shall also act as an advocate for health concerns of rural coun-
- 13 ties in the development of certificate of need review standards
- 14 under this part
