Environmental protection bond implementation act being section 299 681 of the Michigan Compiled Laws

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Section 11 of Act No 328 of the Public Acts of
- 2 1988 being section 299 681 of the Michigan Compiled Laws, is
- 3 amended to read as follows
- 4 Sec 11 The commission DEPARTMENT shall not make a grant
- $\mathbf{5}$ or a loan under section 8(1)(a) or (b) unless all of the follow-
- 6 ing conditions are met
- 7 (a) The applicant demonstrates that the proposed project is
- 8 in compliance with all applicable state laws and rules, or the
- 9 proposed project will result in compliance with state laws and
- 10 rules

- (b) The applicant demonstrates to the commission
- 2 DEPARTMENT the capability to carry out the proposed project
- 3 (c) The applicant provides the -commission DEPARTMENT with
- 4 evidence that a licensed professional engineer has approved the
- 5 plans and specifications for the project, if appropriate
- 6 (d) The applicant demonstrates to the commission
- 7 DEPARTMENT that there is an identifiable source of funds for the
- 8 future maintenance and operation of the proposed project
- 9 (E) THE APPLICANT CERTIFIES TO THE DEPARTMENT THAT THEY WILL
- 10 EMPLOY MICHIGAN RESIDENTS OR CONTRACT WITH ANY ENTITY THAT
- 11 EMPLOYS MICHIGAN RESIDENTS TO WORK ON THE PROPOSED PROJECT UNLESS
- 12 THE DEPARTMENT MAKES A WRITTEN DETERMINATION THAT EMPLOYING
- 13 NONMICHIGAN RESIDENTS OR CONTRACTING WITH AN ENTITY THAT EMPLOYS
- 14 NONMICHIGAN RESIDENTS IS NECESSARY FOR THE TIMELY COMPLETION OF
- 15 THE PROPOSED PROJECT AND THAT THERE ARE NO MICHIGAN RESIDENTS OR
- 16 ENTITIES THAT EMPLOY MICHIGAN RESIDENTS AVAILABLE TO WORK ON THE
- 17 PROPOSED PROJECT
- 18 (F) THE APPLICANT CERTIFIES TO THE DEPARTMENT THAT THEY WILL
- 19 COMPETITIVELY BID ALL GOODS AND SERVICES JSED IN THE PROPOSED
- 20 PROJECT UNLESS THE DEPARTMENT MAKES A WRITTEN DETERMINATION THAT
- 21 ANOTHER FORM OF PROCUREMENT IS NECESSARY AND THAT THE COMPETITIVE
- 22 BIDDING PROCESS WILL BE OPEN TO ALL MICHIGAN RESIDENTS AND
- 23 MICHIGAN BUSINESSES
