

SENATE BILL No. 216

January 26, 1993, Introduced by Senators GEAKE, EHLERS, CISKY, DI NELLO, DILLINGHAM, MC MANUS, EMMONS, VAN REGENMORTER, WELBORN, BOUCHARD, DUNASKISS, SCHWARZ, GAST, POSTHUMUS and WARTNER and referred to the Committee on Transportation and Tourism.

A bill to amend section 5 of Act No. 187 of the Public Acts of 1990, entitled

"The pupil transportation act,"

being section 257.1805 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 5 of Act No. 187 of the Public Acts of
- 2 1990, being section 257.1805 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- Sec. 5. (1) "Modified school bus" means a school bus of any
- 5 age with a factory installed fuel system which has been modified
- 6 to operate on a fuel source other than gasoline or diesel fuel.
- 7 (2) "Nonpublic school" means a private school, a denomina-
- 8 tional school, or a parochial school as defined by law.

- 1 (3) "Public school" means a local school district, a local
 2 act school district, or an intermediate school district as
 3 defined by law.
- 4 (4) "Pupil transportation vehicle" means any vehicle other
- 5 than a school bus used to transport pupils to or from school or
- 6 school-related events. Pupil transportation vehicle does not
- 7 include a vehicle operated by a municipally owned transportation
- 8 system, or by a carrier certified by the state transportation
- 9 department, OR BY A PARENT, GUARDIAN, OR PARENT'S DESIGNEE OR A
- 10 SCHOOL EMPLOYEE WHO IS NOT A REGULAR OR SUBSTITUTE DRIVER FOR
- 11 REGULARLY SCHEDULED TRANSPORTATION OF PASSENGERS TO AND FROM
- 12 HOME.
- (5) "Rehabilitated school bus" means a bus which is at least
- 14 4 years old and has accumulated at least 100,000 miles, or is 7
- 15 years old; and which has been thoroughly inspected and had all
- 16 systems repaired, replaced, or adjusted to meet the department of
- 17 state police inspection requirements including but not limited
- 18 to:
- 19 (a) Engine overhaul of short block.
- 20 (b) New tires on the front axle.
- 21 (c) New recap tires on the rear axle.
- 22 (d) New brake linings and drums.
- (e) New hydraulic brake lines.
- 24 (f) New front and rear springs.
- 25 (g) New paint in the interior.
- 26 (h) New exhaust system.

- 1 (6) "Rule" means a rule promulgated pursuant to the
 2 administrative procedures act of 1969, Act No. 306 of the Public
 3 Acts of 1969, being sections 24.201 to 24.328 of the Michigan
 4 Compiled Laws.
- 5 (7) "School" means either a public school or a nonpublic 6 school, or both.
