- 5 SEC. 757. (1) IF A TREASURER OR CHIEF FINANCIAL OFFICER OF
- 6 AN INTERMEDIATE SCHOOL DISTRICT ACTED AS A REGIONAL CONTROLLER
- 7 UNDER FORMER SECTION 752 OR 753 AND IS IN POSSESSION AT THE TIME
- 8 OF THE EFFECTIVE DATE OF THIS SECTION OF MONEY PAID BY A SCHOOL

- 1 DISTRICT PURSUANT TO EITHER OF THOSE SECTIONS, THEN NOT LATER
- 2 THAN 30 DAYS AFTER THE EFFECTIVE DATE OF THIS SECTION THE TREA-
- 3 SURER OR CHIEF FINANCIAL OFFICER SHALL REPAY TO THE SCHOOL DIS-
- 4 TRICT A SUM EQUAL TO ALL MONEY PAID BY THE SCHOOL DISTRICT UNDER
- 5 FORMER SECTION 752 OR 753 PLUS THE INTEREST EARNED ON THAT MONEY

- 9 THEN NOT LATER THAN 60 DAYS AFTER THE EFFECTIVE DATE OF THIS SEC-
- 10 TION THE STATE TREASURER SHALL REPAY TO THE SCHOOL DISTRICT A SUM
- 11 EQUAL TO ALL MONEY PAID BY THE SCHOOL DISTRICT UNDER FORMER
- 12 SECTION 752 OR 753 PLUS INTEREST FROM THE DATE THE SCHOOL DIS-
- 13 TRICT PAID THE MONEY. THE INTEREST SHALL BE COMPUTED AT THE CUR-
- 14 RENT MONTHLY RATE OF 1 PERCENTAGE POINT ABOVE THE ADJUSTED PRIME
- 15 RATE PER ANNUM, AS CERTIFIED BY THE DEPARTMENT OF TREASURY. TO
- 16 CLAIM REPAYMENT UNDER THIS SUBSECTION, A SCHOOL DISTRICT SHALL
- 17 FILE A CLAIM WITH THE DEPARTMENT OF TREASURY NOT LATER THAN 45
- 18 DAYS AFTER THE EFFECTIVE DATE OF THIS SECTION IN A FORM AND
- 19 MANNER AS PRESCRIBED BY THE DEPARTMENT OF TREASURY.
- 20 (3) AS USED IN THIS SECTION, "ADJUSTED PRIME RATE" MEANS THE
- 21 AVERAGE PREDOMINANT PRIME RATE QUOTED BY NOT LESS THAN 3 COMMER-
- 22 CIAL FINANCIAL INSTITUTIONS TO LARGE BUSINESSES, AS DETERMINED BY
- 23 THE DEPARTMENT OF TREASURY.
- Section 2. Sections 751 to 756 of Act No. 451 of the Public
- 25 Acts of 1976, being sections 380.751 to 380.756 of the Michigan
