March 23, 1994, Introduced by Senator BOUCHARD and referred

A bill to amend sections 507 and 534 of Act No 236 of the  
Public Acts of 1961 entitled as amended  
"Revised judicature act of 1961 "  
section 507 as amended by Act No 134 of the Public Acts of 1988  
and section 534 as amended by Act No 129 of the Public Acts of  
1980, being sections 600 507 and 600 534 of the Michigan Compiled  
Laws and to add section 5491

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

1 Section 1 Sections 507 and 534 of Act No 236 of the  
2 Public Acts of 1961 section 507 as amended by Act No 134 of the  
3 Public Acts of 1988 and section 534 as amended by Act No 129 of  
4 the Public Acts of 1980 being sections 600 507 and 600 534 of  
5 the Michigan Compiled Laws, are amended and section 5491 is added  
6 to read as follows
