## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 1 Section 1 Sections 367, 370, and 974 of Act No 116 of the
- 2 Public Acts of 1954, section 370 as amended by Act No 83 of the
- 3 Public Acts of 1990, being sections 168 367, 168 370, and 168 974
- 4 of the Michigan Compiled Laws, are amended to read as follows
- 5 Sec 367 (1) Resignation of a township officer shall be in
- 6 writing, signed by the officer resigning, and addressed to the
- 7 township board, and shall be delivered to and filed by the
- 8 township clerk

- 1 (2) THE RESIGNING TOWNSHIP OFFICER IS NOT ELIGIBLE TO BE
- 2 APPOINTED OR ELECTED TO ANY EXISTING OR NEWLY CREATED TOWNSHIP
- 3 OFFICE FOR THE REMAINDER OF THE UNEXPIRED TERM OF THE RESIGNING
- 4 TOWNSHIP OFFICER
- 5 Sec 370 (1) Except as provided in subsection (2), if a
- 6 vacancy occurs in an elective or appointive township office, the
- 7 vacancy shall be filled by appointment by A QUORUM OF THE ELECTED
- 8 TOWNSHIP BOARD MEMBERS SERVING ON the township board, and the
- 9 person appointed shall hold the office for the remainder of the
- 10 unexpired term
- 11 (2) If 1 or more vacancies occur in an elective township
- 12 office -that cause the number of members serving on the township
- 13 board to be less than the minimum number of board members that is
- 14 required to constitute a quorum for the transaction of business
- 15 by the board, the board of county election commissioners shall
- 16 make temporary appointment of the number of members required to
- 17 constitute a quorum for the transaction of business by the town-
- 18 ship board An official appointed under this subsection shall
- 19 hold the office only until the official's successor is elected or
- 20 appointed and qualified An official who is temporarily
- 21 appointed under this subsection shall not vote on -the- AN
- 22 appointment -of himself or herself to FILL A VACANCY IN an elec-
- 23 tive or appointive township office
- 24 (3) If a township official submits a written resignation
- 25 from an elective township office for circumstances other than a
- 26 resignation related to a recall election, which specifies a date
- 27 and time at which the resignation is effective, the township

- 1 board, within 30 days before that effective date and time, may
- 2 appoint a person to fill the vacancy at the effective date and
- 3 time of the resignation The resigning official shall not vote
- 4 on the appointment AND, FOR THE PURPOSES OF SUBSECTION (1), SHALL
- 5 NOT BE CONSIDERED AN ELECTED TOWNSHIP BOARD MEMBER SERVING ON THE
- 6 BOARD FOR THE PURPOSES OF THIS SUBSECTION, "RESIGNATION RELATED
- 7 TO A RECALL" MEANS A RESIGNATION FOLLOWING THE DETERMINATION OF
- 8 THE BOARD OF COUNTY ELECTION COMMISSIONERS UNDER SECTION 952 THAT
- 9 THE REASONS FOR RECALL STATED IN A RECALL PETITION ARE OF SUFFI-
- 10 CIENT CLARITY
- 11 (4) Except as provided in subsection (5), if the township
- 12 board does not make an appointment under subsection (3), or if a
- 13 vacancy occurs in an elective township office and the vacancy is
- 14 not filled by the township board or the board of county election
- 15 commissioners within 45 days after the beginning of the vacancy,
- 16 the county clerk of the county in which the township is located
- 17 shall notify the governor of the fact The governor shall call a
- 18 special election to fill the vacancy The governor shall provide
- 19 for the date for the filing of the petitions -, which THIS date
- 20 shall also be the last date to register for the special primary
- 21 election Notwithstanding section 358a, the special primary or
- 22 special general election may be held within 60 days of a state
- 23 primary or a state general election A special primary or
- 24 SPECIAL GENERAL election called by the governor under authority
- 25 of this section shall not affect the rights of a qualified elec-
- 26 tor to register for any other election A person elected to fill
- 27 a vacancy shall serve for the remainder of the unexpired term

- 1 (5) Subsection (4) -shall DOES not apply to the office of
- 2 township constable If a vacancy occurs in the office of town-
- 3 ship constable, the township board shall determine if and when
- 4 the vacancy shall be filled If the township board does not fill
- 5 the vacancy, the office of township constable shall remain vacant
- 6 until the next general or special election in which the township
- 7 offices are filled
- 8 Sec 974 (1) An officer who was recalled shall not be a
- 9 candidate to fill the vacancy created by the recall -nor- AND
- 10 SHALL NOT be appointed to fill a vacancy in an elective OR
- 11 APPOINTIVE office in the electoral district or governmental unit
- 12 from which the recall was made during the term of office from
- 13 which the officer was recalled
- (2) An officer who has resigned subsequent to the filing of
- 15 a recall petition shall not be appointed to fill a vacancy in AN
- 16 elective office in that electoral district or governmental unit
- 17 during the term of the office from which the officer resigned
- (3) If an officer resigns subsequent to the filing of peti-
- 19 tions to recall that officer from office, it shall not be neces-
- 20 sary for the office with which the recall petitions have been
- 21 filed to proceed under sections 961 and 963
- 22 (4) If an officer whose recall is sought resigns after the
- 23 calling of a recall election, the election shall not be held
