- 5 SEC 401E (1) SUBJECT TO SUBSECTION (2), IF A HEALTH CARE
- 6 CORPORATION GROUP OR NONGROUP CERTIFICATE PROVIDES FOR HEALTH
- 7 CARE BENEFITS FOR SERVICES PERFORMED BY A CERTIFIED NURSE
- 8 SPECIALIST, DIRECT REIMBURSEMENT FOR THOSE BENEFITS AT THE
- 9 PREVAILING RATE SHALL NOT BE DENIED IF THE SERVICES WERE
