- 1 TOWNSHIP BOARD SHALL NOT DIRECT A TOWNSHIP MANAGER OR OTHER
- 2 EMPLOYEE TO PERFORM duties that are delegated by law to another
- 3 township official, unless -consent has been granted THAT OFFI-
- 4 CIAL HAS CONSENTED
- 5 (2) THE TOWNSHIP BOARD MAY ENTER INTO AN EMPLOYMENT CONTRACT
- 6 WITH A TOWNSHIP MANAGER EXTENDING BEYOND THE TERMS OF THE MEMBERS
- 7 OF THE TOWNSHIP BOARD AN EMPLOYMENT CONTRACT WITH A TOWNSHIP
- 8 MANAGER SHALL BE IN WRITING AND SHALL SPECIFY THE COMPENSATION TO
- 9 BE PAID TO THE TOWNSHIP MANAGER, ANY PROCEDURE FOR CHANGING THE
- 10 COMPENSATION, ANY FRINGE BENEFITS, AND ANY OTHER CONDITIONS OF
- 11 EMPLOYMENT THE CONTRACT SHALL STATE THAT THE TOWNSHIP MANAGER
- 12 SERVES AT THE PLEASURE OF THE TOWNSHIP BOARD THE CONTRACT MAY
- 13 PROVIDE FOR SEVERANCE PAY OR OTHER BENEFITS IN THE EVENT THE
- 14 EMPLOYMENT OF THE TOWNSHIP MANAGER IS TERMINATED AT THE PLEASURE
- 15 OF THE TOWNSHIP BOARD
