- 6 Sec 17048 (1) Except as otherwise provided in this
- 7 subsection and section 17049(5), a physician who is a sole
- 8 practitioner or who practices in a group of physicians and treats

- 17 Sec 17076 (1) Except in an emergency situation, a
- 18 physician's assistant shall provide medical care services only
- 19 under the supervision of a physician or properly designated
- 20 alternative physician, and only if those medical care services
- 21 are within the scope of practice of the supervising physician and
- 22 are delegated by the supervising physician
- (2) A physician's assistant shall provide medical care serv-
- 24 ices only in a medical care setting where the supervising physi-
- 25 clan regularly sees patients However, a physician's assistant
- 26 may make calls or go on rounds UNDER THE SUPERVISION OF A
- 27 PHYSICIAN in private homes, public institutions, emergency

- 1 vehicles, ambulatory care clinics, hospitals, intermediate or
- 2 extended care facilities, health maintenance organizations, nurs-
- 3 ing homes, or other health care facilities to the extent permit-
- 4 ted by the bylaws, rules, or regulations of the -facilities or
- 5 organizations under the supervision of a physician GOVERNING
- 6 FACILITY OR ORGANIZATION, IF ANY
- 7 (3) A physician's assistant may prescribe drugs as a dele-
- 8 gated act of a supervising physician, but shall do so only in
- 9 accordance with procedures and protocol for the prescription
- 10 established by the boards in rule OF THE APPROPRIATE BOARD
- 11 Until the rules are promulgated, a physician's assistant may pre-
- 12 scribe a drug other than a controlled substance as defined by
- 13 article 7 or federal law, as a delegated act of the supervising
- 14 physician When delegated prescription occurs, the supervising
- 15 physician's name shall be used, recorded, or otherwise indicated
- 16 in connection with each individual prescription so that the indi-
- 17 vidual who dispenses or administers the prescription knows under
- 18 whose delegated authority the physician's assistant is
- 19 prescribing
- 20 (4) A PHYSICIAN'S ASSISTANT MAY ORDER, RECEIVE, AND DISPENSE
- 21 COMPLIMENTARY STARTER DOSE DRUGS OTHER THAN CONTROLLED SUBSTANCES
- 22 AS DEFINED BY ARTICLE 7 OR FEDERAL LAW AS A DELEGATED ACT OF A
- 23 SUPERVISING PHYSICIAN WHEN THE DELEGATED ORDERING, RECEIPT, OR
- 24 DISPENSING OF COMPLIMENTARY STARTER DOSE DRUGS OCCURS, THE SUPER-
- 25 VISING PHYSICIAN'S NAME SHALL BE USED, RECORDED, OR OTHERWISE
- 26 INDICATED IN CONNECTION WITH EACH ORDER, RECEIPT, OR DISPENSING
- 27 SO THAT THE INDIVIDUAL WHO PROCESSES THE ORDER FOR OR DELIVERS
