- 3 amended and section 108a is added to read as follows

- 5 (A) "BILL REQUEST" MEANS A LEGISLATOR'S REQUEST THAT THE
- 6 BUREAU DRAFT A BILL OR A JOINT RESOLUTION
- 7 (B) "BLUEBACK" MEANS THE COPY OF A BILL WITH A BLUE BACKING
- 8 THAT IS USED FOR THE SIGNATURES OF SPONSORING MEMBERS OF THE
- 9 LEGISLATURE

- 1 (C) "BUREAU" MEANS THE LEGISLATIVE SERVICE BUREAU
- 2 (D) -(a) "Council" means the legislative council
- 3 (b) "Bureau" means the legislative service bureau
- 4 (E) (C) "Commission" means the Michigan law revision
- 5 commission
- 6 (F) "ORANGEBACK" MEANS THE COPY OF A JOINT RESOLUTION WITH
- 7 AN ORANGE BACKING THAT IS USED FOR THE SIGNATURE OF SPONSORING
- 8 MEMBERS OF THE LEGISLATURE
- 9 (G) "REINTRODUCTION REQUEST" MEANS A BILL REQUEST FOR A
- 10 BLUEBACK, ORANGEBACK, STAR RUN, SUBSTITUTE BILL, OR SUBSTITUTE
- 11 JOINT RESOLUTION DELIVERED DURING THE IMMEDIATELY PRECEDING
- 12 2-YEAR LEGISLATIVE SESSION FOR WHICH NO REVISIONS ARE REQUESTED
- 13 BY THE LEGISLATOR SUBMITTING THE BILL REQUEST OTHER THAN AMEND-
- 14 MENTS ADOPTED BY EITHER HOUSE
- 15 (H) "STAR RUN" MEANS A BILL OR JOINT RESOLUTION TO REVISE
- 16 AND REPLACE A BLUEBACK OR ORANGEBACK THAT HAS BEEN DELIVERED TO A
- 17 LEGISLATOR BUT NOT INTRODUCED
- 18 SEC 108A (1) THE BUREAU SHALL NUMBER BILL REQUESTS IN THE
- 19 ORDER IN WHICH THE BILL REQUESTS ARE RECEIVED BY THE BUREAU TO
- 20 THE EXTENT POSSIBLE, THE BUREAU SHALL PROCESS BILL REQUESTS BY
- 21 BILL REQUEST NUMBER HOWEVER, SUBJECT TO SUBSECTION (2), THE
- 22 BUREAU SHALL REMOVE FROM NUMERICAL SEQUENCE AND PROCESS A BILL
- 23 REQUEST GIVEN A PRIORITY DESIGNATION UNDER SUBSECTION (3), (4),
- 24 OR (5) BEFORE ALL OTHER BILL REQUESTS EXCEPT THOSE PREVIOUSLY
- 25 GIVEN A PRIORITY DESIGNATION

- 1 (2) THE LEGISLATIVE COUNCIL MAY ADOPT RULES AND REGULATIONS
- 2 PROVIDING THAT THE BUREAU SHALL PROCESS ON A PRIORITY BASIS AS
- 3 SPECIFIED BY THE RULES 1 OR MORE OF THE FOLLOWING
- 4 (A) A CONFERENCE COMMITTEE REPORT
- 5 (B) AN AMENDMENT
- 6 (C) A SUBSTITUTE BILL
- 7 (D) A BILL REQUEST WHOSE SUBJECT AND PURPOSE ARE SUFFI-
- 8 CIENTLY SIMILAR TO, OR THE SAME AS, THOSE OF A HIGHER NUMBERED
- 9 BILL REQUEST DESIGNATED AS A PRIORITY UNDER SUBSECTION (3), (4),
- **10** OR (5)
- 11 (E) A REINTRODUCTION REQUEST
- 12 (F) A STAR RUN
- 13 (3) DURING A 2-YEAR LEGISLATIVE SESSION, A LEGISLATOR MAY
- 14 REQUEST AND SHALL RECEIVE A PRIORITY DESIGNATION ON NOT MORE THAN
- 15 5 OF HIS OR HER BILL REQUESTS
- 16 (4) DURING A 2-YEAR LEGISLATIVE SESSION, THE LEADER OF
- 17 EITHER OF THE 2 MAJOR PARTIES IN EACH HOUSE OF THE LEGISLATURE
- 18 MAY REQUEST AND SHALL RECEIVE A PRIORITY DESIGNATION ON NOT MORE
- 19 THAN 10 OF HIS OR HER BILL REQUESTS OR BILL REQUESTS OF ANOTHER
- 20 MEMBER OF THAT HOUSE PRIORITY DESIGNATIONS UNDER THIS SUBSEC-
- 21 TION ARE IN ADDITION TO PRIORITY DESIGNATIONS UNDER SUBSECTION
- 22 (3) OR (5)
- 23 (5) DURING A 2-YEAR LEGISLATIVE SESSION, THE CHAIRPERSON OF
- 24 THE SENATE APPROPRIATIONS COMMITTEE, THE SENATE FINANCE COMMIT-
- 25 TEE, THE HOUSE APPROPRIATIONS COMMITTEE, OR THE HOUSE TAXATION
- 26 COMMITTEE, OR A SUCCESSOR COMMITTEE MAY REQUEST AND SHALL RECEIVE
- 27 A PRIORITY DESIGNATION ON NOT MORE THAN 10 OF HIS OR HER BILL

- 1 REQUESTS, OR BILL REQUESTS OF A MEMBER OF THE COMMITTEE, THAT
- 2 RELATE ONLY TO THE SUBJECT MATTER OF LEGISLATION CONSIDERED BY
- 3 THE COMMITTEE IF THE CHAIR OF A COMMITTEE ALTERNATES BETWEEN
- 4 MEMBERS OF 2 POLITICAL PARTIES, THE CHAIRPERSONS REPRESENTING
- 5 EACH POLITICAL PARTY MAY REQUEST AND SHALL RECEIVE 5 PRIORITY
- 6 DESIGNATIONS AS PROVIDED BY THIS SUBSECTION DURING A 2-YEAR LEG-
- 7 ISLATIVE SESSION PRIORITY DESIGNATIONS UNDER THIS SUBSECTION
- 8 ARE IN ADDITION TO PRIORITY DESIGNATIONS UNDER SUBSECTION (3) OR
 9 (4)
- 10 (6) THE LEGISLATIVE COUNCIL MAY ADOPT RULES AND REGULATIONS
- 11 PROHIBITING A PRIORITY DESIGNATION FROM BEING REQUESTED AFTER A
- 12 SPECIFIED DATE ON AN EVEN NUMBERED YEAR
- Section 2 This amendatory act shall apply to bill requests
- 14 for legislatures beginning with the 88th Legislature
- 15 Section 3 This amendatory act shall take effect November
