A bill to amend 1976 PA 451, entitled  
"The revised school code,"  
by amending section 1233 (MCL 380.1233), as amended by 1995 PA  
289.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 1233. (1) Except as ~~provided in this section and sec-~~  
2 ~~tion 1233b~~ OTHERWISE PROVIDED BY LAW, the board of a school dis-  
3 trict or INTERMEDIATE SCHOOL BOARD OF AN intermediate school dis-  
4 trict shall not permit a teacher who does not hold a valid teach-  
5 ing certificate to teach in a grade or department of the school.  
6 ~~, or a teacher without an endorsement by the state board~~  
7       (2) THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL  
8 BOARD OF AN INTERMEDIATE SCHOOL DISTRICT SHALL NOT ALLOW AN  
9 INDIVIDUAL to serve in a counseling role IN THE SCHOOL DISTRICT  
10 OR INTERMEDIATE SCHOOL DISTRICT, as the role is defined by the

15 (C) GUIDANCE INFORMATION--VOCATIONAL DEVELOPMENT THEORY,  
16 EDUCATIONAL AND OCCUPATIONAL INFORMATION.

17 (D) COUNSELING THEORY AND PRACTICE--INDIVIDUAL AND GROUP  
18 PROCEDURES, ADMINISTRATION AND COORDINATION RELATIONSHIPS, PRO-  
19 FESSIONAL RELATIONSHIPS, AND ETHICS.

20 (E) SUPERVISED EXPERIENCES--LABORATORY, PRACTICUM, OR

3 (4) A vocational teacher preparation institution shall uti-  
4 lize the employment experience of an annually authorized teacher  
5 for the purpose of waiving student teaching as a requirement for  
6 vocational certification if the annually authorized teacher is  
7 supervised by the teacher preparation institution.

8 (5) All vocational education teachers certified after  
9 June 1, 1995 shall pass a competency test.

10 (6) The board of a school district or intermediate school  
11 district may employ a person without a teaching certificate as a  
12 substitute teacher if the person has at least 90 semester hours  
13 of college credit from a college or university.

14 (7) IF THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL  
15 BOARD OF AN INTERMEDIATE SCHOOL DISTRICT CHOOSES TO EMPLOY AN  
16 INDIVIDUAL WHO DOES NOT HOLD A VALID TEACHING CERTIFICATE TO  
17 SERVE IN A COUNSELING ROLE, AS PERMITTED UNDER SUBSECTION (2),  
18 THE SCHOOL BOARD OR INTERMEDIATE SCHOOL BOARD SHALL COMPLY WITH  
19 SECTIONS 1230 AND 1230A WITH RESPECT TO THAT INDIVIDUAL TO THE  
20 SAME EXTENT AS REQUIRED FOR EMPLOYING A PERSON WITH A TEACHING  
21 CERTIFICATE TO SERVE AS A TEACHER.
