- 9 (2) THE NOTIFICATION REQUIRED UNDER SUBSECTIONS (1) AND (3)
- 10 SHALL INCLUDE THE NAME, ADDRESS, AND DATE OF BIRTH OF THE
- 11 JUVENILE.

- 1 (3) IF THE JUVENILE MOVES TO ANOTHER ADDRESS, THE DEPARTMENT
