A SUMMARY OF HOUSE BILLS 6294 - 6318 AS INTRODUCED 9-17-02

House Bill 6317 would amend the Friend of the Court Act (MCL 552.501 et al.) to rename it as the Friend of the Child Act, and would replace references to the “Friend of the Court” with “Friend of the Child”, and make other technical amendments to the act. The remainder of the package of bills, all of which are tie-barred to House Bill 6317, would amend various acts to replace references to the “Friend of the Court”, inserting instead references to the “Friend of the Child”, and make other technical amendments as well.

House Bill 6294 would amend the Revised Judicature Act of 1961 (MCL 600.1201 et al.).

House Bill 6295 would amend the L.E.I.N. Policy Council Act of 1974 (MCL 28.214).

House Bill 6296 would amend Public Act 122 of 1941, an act regulating the Revenue Division of the Department of Treasury (MCL 205.28).

House Bill 6297 would amend the Paternity Act (MCL 722.714 et al.).

House Bill 6298 would amend the Uniform Interstate Family Support Act (MCL 552.1308 and 552.1312).

House Bill 6299 would amend the Interstate Income Withholding Act (MCL 552.673 et al.).

House Bill 6300 would amend Public Act 379 of 1913, an act regulating the collection of alimony, support, and maintenance payments (MCL 552.152 and 552.156).

House Bill 6301 would amend the Office of Child Support Act (MCL 400.231 et al.).

House Bill 6302 would amend the Michigan Vehicle Code (MCL 257.221).

House Bill 6303 would amend the Regulated Occupation Support Enforcement Act (MCL 338.3432).

House Bill 6304 would amend Public Act 261 of 1947, an act relating to the compensation, powers, and duties of certain officers and employees of counties with a population of 1 million or more (MCL 45.454).

House Bill 6311 would amend Public Act 60 of 1962, an act governing day parole of prisoners (MCL 801.252 et al.).

House Bill 6312 would amend the Revised Uniform Reciprocal Enforcement of Support Act (MCL 780.153a et al.).

House Bill 6313 would amend the Michigan Penal Code (MCL 750.165).

House Bill 6314 would amend Public Act 293 of 1968, an act relating to the status of minors and their support (MCL 722.3).

House Bill 6315 would amend Chapter 84 of the Revised Statutes of 1846, entitled "Of Divorce" (MCL552.15 et al.).

House Bill 6316 would amend the Group Health Plan Act (MCL 550.1807).

House Bill 6318 would amend the Support and Parenting Time Enforcement Act (552.602 et al.).
