- 7 OPTOMETRIST DESCRIBING OPTICAL AND PHYSICAL CHARACTERISTICS OF
- 8 CONTACT LENSES TO BE DISPENSED.
- 9 [(B)] "CONTACT LENS PROVIDER" MEANS A PERSON, WHETHER LOCATED
- 10 WITHIN OR OUTSIDE OF MICHIGAN, WHO DISPENSES, SELLS, OR PROVIDES
- 11 CONTACT LENSES TO A MICHIGAN RESIDENT.

- 18 (C) THE TELEPHONE NUMBER OF THE CONTACT LENS PROVIDER.
- 19 (D) IF THE CONTACT LENS PROVIDER IS NOT LOCATED IN THIS
- 20 STATE, THE NAME OF A RESIDENT AGENT IN THIS STATE FOR ACCEPTANCE
- 21 OF SERVICE OF PROCESS.
- 22 (E) A DECLARATION THAT THE CONTACT LENS PROVIDER WILL COMPLY
- 23 WITH ALL APPLICABLE LAWS AND REGULATIONS IN THE CONDUCT OF ITS
- 24 BUSINESS IN MICHIGAN.
- 25 (2) A PHYSICIAN OR OPTOMETRIST IS NOT REQUIRED TO REGISTER
- 26 UNDER SUBSECTION (1) UNTIL HIS OR HER NEXT LICENSE RENEWAL DATE
- 27 THAT IMMEDIATELY FOLLOWS THE EFFECTIVE DATE OF THIS SECTION.
