

HOUSE BILL No. 4782

May 17, 2001, Introduced by Reps. Sanborn, Richner and Bisbee and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 161 of chapter XVII (MCL 777.161), as amended by 2000 PA 279.
