## **SENATE BILL No. 53**

January 30, 2001, Introduced by Senators SHUGARS, NORTH and STEIL and referred to the Committee on Judiciary.

A bill to amend 1963 PA 17, entitled

"An act to relieve certain persons from civil liability when rendering emergency care, when rendering care to persons involved in competitive sports under certain circumstances, or when participating in a mass immunization program approved by the department of public health,"

(MCL 691.1501 to 691.1507) by adding section 8.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 8. (1) A PERSON WHO, WITHOUT COMPENSATION OR THE
- 2 EXPECTATION OF COMPENSATION, RENDERS EMERGENCY CARE, ADVICE, OR
- 3 ASSISTANCE AT THE SCENE OF AN EMERGENCY OR DURING TRANSIT TO A
- 4 LOCATION WHERE PROFESSIONAL MEDICAL CARE CAN BE RENDERED IS NOT
- 5 LIABLE FOR ANY CIVIL DAMAGES AS A RESULT OF ACTS OR OMISSIONS BY
- 6 THAT PERSON IN RENDERING THE EMERGENCY CARE, ADVICE, OR ASSIST-
- 7 ANCE, UNLESS THE PERSON ACTS IN A RECKLESS OR WILLFUL AND WANTON
- 8 MANNER IN PROVIDING THE CARE, ADVICE, OR ASSISTANCE. THIS
- 9 SECTION DOES NOT APPLY TO A PERSON RENDERING EMERGENCY CARE,

- 18 TEER FIREFIGHTER, VOLUNTEER POLICE OFFICER, VOLUNTEER AMBULANCE
- 19 ATTENDANT, VOLUNTEER FIRST PROVIDER OF EMERGENCY MEDICAL SERV-
- 20 ICES, VOLUNTEER SKI PATROLLER, AND ANY PARTNERSHIP, CORPORATION,
- 21 ASSOCIATION, OR OTHER ENTITY.
