

# HOUSE BILL No. 5772

April 1, 2004, Introduced by Reps. Ruth Johnson, LaJoy, Farrah, Ward and Koetje and referred to the Committee on Land Use and Environment.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 13c of chapter XVII (MCL 777.13c), as added by 2002 PA 30.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

CHAPTER XVII

Sec. 13c. This chapter applies to the following felonies enumerated in chapter 324 of the Michigan Compiled Laws:
