

# SENATE BILL No. 784

October 21, 2003, Introduced by Senators CASSIS, McMANUS, GOSCHKA, JELINEK, HARDIMAN, BIRKHOLZ, BRATER and BASHAM and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16t of chapter XVII (MCL 777.16t), as amended by 2000 PA 371.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

CHAPTER XVII

Sec. 16t. This chapter applies to the following felonies enumerated in chapter 750 of the Michigan Compiled Laws:
