- 25 REQUIREMENTS SUBSTANTIALLY EQUAL TO THOSE EXISTING IN THIS STATE
- 26 OR UNDER A PROGRAM APPROVED BY A CHIROPRACTIC PHYSICIAN, OR A
- 27 PHYSICIAN, WHO IS LICENSED UNDER PART 164, 170, OR 175 OR BY

- 1 ANOTHER STATE THAT HAS LICENSING REQUIREMENTS SUBSTANTIALLY EQUAL
- 2 TO THOSE EXISTING IN THIS STATE.
