

# HOUSE BILL No. 5045

July 24, 2007, Introduced by Reps. Miller, Accavitti, Alma Smith and Constan and referred to the Committee on Transportation.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 12e of chapter XVII (MCL 777.12e), as amended by 2004 PA 26.

CHAPTER XVII

Sec. 12e. This chapter applies to the following felonies enumerated in sections 601 to 624b of chapter VI of the Michigan vehicle code, 1949 PA 300, within chapter 257 of the Michigan Compiled Laws:
