

# SENATE BILL No. 1312

April 29, 2010, Introduced by Senators OLSHOVE, WHITMER, JACOBS, SWITALSKI, ANDERSON, HUNTER, GLEASON, BRATER, CHERRY, PRUSI, PATTERSON, BROWN, NOFS and RICHARDVILLE and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 160 of chapter XVII (MCL 777.160), as amended by 2004 PA 457.
