A bill to amend 2000 PA 92, entitled

"Food law of 2000,"

(MCL 289.1101 to 289.8111) by amending the title and by adding section 5104.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

An act to codify the licensure and regulation of certain persons engaged in processing, manufacturing, production, packing, preparing, repacking, canning, preserving, freezing, fabricating, storing, selling, serving, or offering for sale food or drink for human consumption; to prescribe powers and duties of the department of agriculture; to provide for delegation of certain powers and

- 2 to regulate the labeling, manufacture, distribution, and sale of

- 4 and deception by prohibiting the misbranding, adulteration,

- 12 SEC. 5104. A PERSON INCLUDING, BUT NOT LIMITED TO, A PERSON

- 14 WHOLESALE PROCESSOR, OR DISTRIBUTOR, WHO DONATED FOOD FOR USE OR
- 15 DISTRIBUTION BY A NONPROFIT ORGANIZATION OR NONPROFIT CORPORATION,
- 16 AND A NONPROFIT ORGANIZATION OR NONPROFIT CORPORATION THAT COLLECTS
- 17 DONATED FOOD AND DISTRIBUTES THAT FOOD TO ANOTHER NONPROFIT
- 18 ORGANIZATION OR NONPROFIT CORPORATION FREE OF CHARGE OR FOR A
- 19 NOMINAL FEE, IS NOT LIABLE FOR ANY CIVIL DAMAGES OR SUBJECT TO
- 20 CRIMINAL LIABILITY RESULTING FROM THE NATURE, AGE, CONDITION, OR
- 21 PACKAGING OF THE FOOD UNLESS IT IS ESTABLISHED THAT THE DONOR OR
- 22 NONPROFIT ORGANIZATION OR NONPROFIT CORPORATION KNEW OR HAD
- 23 REASONABLE GROUNDS TO KNOW, AT THE TIME OF MAKING THE DONATION OR
- 24 DISTRIBUTION, THAT THE FOOD WAS ADULTERATED OR NOT FIT FOR HUMAN
- 25 CONSUMPTION.
