

HOUSE BILL No. 6498

September 29, 2010, Introduced by Rep. Neumann and referred to the Committee on Great Lakes and Environment.

A bill to amend 1929 PA 16, entitled

"An act to regulate the business of carrying or transporting, buying, selling or dealing in crude oil or petroleum or its products, through pipe lines; to authorize the use of public highways and the condemnation of private property; to regulate the purchase and storage of crude oil or petroleum; to provide for the control and regulation of all corporations, associations and persons engaged in such business, by the Michigan public utilities commission; to define the powers and duties of the commission in relation thereto; and to prescribe penalties for violations of the provisions hereof,"

(MCL 483.1 to 483.11) by adding section 3a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 **SEC. 3A. (1) A PERSON THAT OWNS OR OPERATES A PIPELINE IN THIS**
2 **STATE SHALL POST AT EACH PARCEL OF PROPERTY IN WHICH THE PIPELINE**
3 **IS LOCATED CONTACT INFORMATION FOR NOTIFYING THE DEPARTMENT OF**
4 **NATURAL RESOURCES AND ENVIRONMENT IN THE EVENT OF A RELEASE FROM**

1 THE PIPELINE.

2 (2) AS USED IN THIS SECTION, "RELEASE" MEANS THAT TERM AS IT
3 IS DEFINED IN SECTION 20101 OF THE NATURAL RESOURCES AND
4 ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, MCL 324.20101.
