

**SUBSTITUTE FOR
SENATE BILL NO. 970**

A bill to amend 1964 PA 284, entitled
"City income tax act,"
by amending section 3 of chapter 1 (MCL 141.503), as amended by
2011 PA 56.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

CHAPTER 1

Sec. 3. (1) The governing body of a city, by a lawfully
adopted ordinance that incorporates by reference the uniform city
income tax ordinance set forth in chapter 2, may levy, assess, and
collect an excise tax on income as provided in the ordinance. The
ordinance shall state the rate of the tax which shall be the rate
authorized by 1 of the following:

(a) The uniform city income tax ordinance under section 11 of

1 chapter 2.

2 (b) Subsection (2).

3 (c) Section 3a, 3b, or 3c of this chapter.

4 (2) ~~Except as otherwise provided in subsections (3), (4), and~~
5 ~~(5), in~~ **IN** a city with a population of more than 600,000, the
6 governing body may levy and collect a tax at a rate to be
7 determined from time to time, that rate to be not more than 2% on
8 corporations and the following maximum tax rates on resident
9 individuals and nonresident individuals for the following years:

10 (a) Before July 1, 1999, 3.00% on resident individuals and
11 1.50% on nonresident individuals.

12 (b) Beginning July 1, 1999 and each July 1 after 1999 **THROUGH**
13 **JULY 1, 2012**, except for 2008 and 2009, the maximum tax rate under
14 this subsection on resident individuals shall be reduced by 0.1
15 until the rate on resident individuals is 2.0%. The tax rate
16 imposed on nonresident individuals shall be 50% of the tax rate
17 imposed on resident individuals each year.

18 (c) Notwithstanding any other provision of this section, for
19 the 2008 and 2009 calendar years, the city shall impose the same
20 tax rate on resident individuals and nonresident individuals as the
21 city had imposed for the 2007 calendar year.

22 **(D) EXCEPT AS OTHERWISE PROVIDED UNDER SUBDIVISION (E),**
23 **BEGINNING JANUARY 1, 2013 AND EACH YEAR AFTER 2013, A RATE OF NOT**
24 **MORE THAN 2.40% ON RESIDENT INDIVIDUALS AND 1.20% ON NONRESIDENT**
25 **INDIVIDUALS.**

26 **(E) BEGINNING JANUARY 1 OF THE YEAR IMMEDIATELY SUCCEEDING THE**
27 **YEAR THAT ALL BONDS, OBLIGATIONS, AND OTHER EVIDENCE OF**

1 INDEBTEDNESS ISSUED BY A LIGHTING AUTHORITY HAVE BEEN FULLY PAID
2 AND EACH YEAR THEREAFTER, A RATE OF NOT MORE THAN 2.20% ON RESIDENT
3 INDIVIDUALS AND 1.10% ON NONRESIDENT INDIVIDUALS.

4 ~~—— (3) If any 3 of the following conditions exist in a city with
5 a population of 600,000 or more, the city may apply to the state
6 administrative board for certification that those conditions exist
7 and the maximum tax rate under subsection (2) (b) shall not be
8 further reduced as provided in subsections (4) and (5):~~

9 ~~—— (a) Funds have been withdrawn from the city's budget
10 stabilization fund for 2 or more consecutive city fiscal years or
11 there is a balance of zero in the city's budget stabilization fund.~~

12 ~~—— (b) The city's income tax revenue growth rate is 0.95 or less.~~

13 ~~—— (c) The local tax base growth rate is 80% or less of the
14 statewide tax base growth rate.~~

15 ~~—— (d) The city's unemployment rate is 10% or higher according to
16 the most recent statistics available from the Michigan jobs
17 commission.~~

18 ~~—— (4) If the state administrative board certifies within 60 days
19 of application that any 3 of the conditions set forth under
20 subsection (3) are met, the maximum tax rate under subsection (2)
21 shall not be further reduced from the date of the state
22 administrative board's certification until the July 1 following the
23 expiration of 1 year after the state administrative board's
24 certification unless the city applies for certification that the
25 conditions continue to exist. Before the expiration of the
26 certification, the city may apply to the state administrative board
27 to certify that the conditions continue to exist and if the state~~

~~1 administrative board so certifies, the certification may continue
2 until the July 1 following the expiration of 1 year after the state
3 administrative board's certification that the conditions continue
4 to exist. The city may continue to apply for certification until
5 the conditions under subsection (3) no longer exist.~~

~~6 (5) Notwithstanding any other provision of this section, if on
7 July 1 the maximum tax rate on resident individuals is reduced
8 under subsection (2) after a year or years in which the maximum tax
9 rate was not reduced because of subsections (3) and (4), the
10 maximum tax rate on resident individuals shall be the maximum tax
11 rate in effect on June 30 of that year reduced by 0.1 and the rate
12 on nonresident individuals shall be 50% of the rate imposed on
13 resident individuals. On each subsequent July 1, subsection (2)
14 applies to the maximum tax rates, subject to subsections (3) and
15 (4).~~

**16 (3) NOTWITHSTANDING ANY OTHER PROVISION OF LAW OR ANY
17 ORDINANCE OF THE CITY TO THE CONTRARY, A CITY THAT FORMS A LIGHTING
18 AUTHORITY SHALL DEPOSIT AN AMOUNT EQUAL TO THE SUM OF THE REVENUE
19 COLLECTED FROM 0.2% OF THE RATE LEVIED ON RESIDENT INDIVIDUALS
20 PURSUANT TO SUBSECTION (2) (D) AND 0.1% OF THE RATE LEVIED ON
21 NONRESIDENT INDIVIDUALS PURSUANT TO SUBSECTION (2) (D) DIRECTLY INTO
22 THE BUDGET OF THE CITY'S POLICE DEPARTMENT AND USE IT EXCLUSIVELY
23 TO RETAIN OR HIRE POLICE OFFICERS. THE TRANSFER AND USE OF THE
24 REVENUE AS PROVIDED UNDER THIS SUBSECTION SHALL CONTINUE UNTIL ALL
25 BONDS, OBLIGATIONS, OR OTHER EVIDENCE OF INDEBTEDNESS ISSUED BY A
26 LIGHTING AUTHORITY HAVE BEEN FULLY PAID AND REVENUE IS NO LONGER
27 BEING PLEDGED FROM TAXES LEVIED UNDER THE CITY UTILITY USERS TAX**

1 ACT, 1990 PA 100, MCL 141.1151 TO 141.1177, TO THE LIGHTING
2 AUTHORITY. AS USED IN THIS SUBSECTION, "LIGHTING AUTHORITY" MEANS A
3 LIGHTING AUTHORITY INCORPORATED UNDER THE MUNICIPAL LIGHTING
4 AUTHORITY ACT.

5 (4) ~~(6)~~—The governing body of a city may adopt the uniform
6 city income tax ordinance with the alternative sections as set
7 forth in chapter 3 instead of the similarly numbered sections as
8 set forth in chapter 2. The uniform city income tax ordinance may
9 be lawfully adopted or rescinded by the governing body at any time.
10 The adoption of an ordinance is effective on and after January 1 or
11 July 1 following adoption of the ordinance, as specified in the
12 ordinance, but an ordinance shall not become effective earlier than
13 45 days after adoption or until approved by the electors if a
14 referendum petition is filed as authorized in this act or a
15 referendum is otherwise required. The rescission of an ordinance
16 shall become effective on the following December 31. The ordinance
17 may be rescinded at any time by the governing body in the same
18 manner in which it was adopted and with appropriate enforcement,
19 collection, and refund provisions with respect to liabilities
20 incurred prior to the effective date of the rescission of the
21 ordinance. The ordinance shall not be amended except as provided by
22 the legislature. A city may amend the ordinance to change the tax
23 rate to a rate authorized by this act.

24 (5) ~~(7)~~—Petitions for a referendum election on the question of
25 adopting an ordinance adopted by the governing body may be filed
26 with the city clerk not later than the sixth Monday following the
27 adoption of the ordinance. The petitions shall be signed by a

1 number of registered electors of the city equal to at least 10%,
2 but not more than 20%, of the registered electors of the city
3 voting in the last general municipal election prior to the adoption
4 of the ordinance by the governing body. If proper petitions are
5 filed, the question of adopting the ordinance shall be submitted by
6 the governing body to the city electors at the next primary or
7 general election or at a special election called for the purpose,
8 in any case held not less than 45 days nor more than 90 days after
9 the clerk has reported the filing of the referendum petition to the
10 city's governing body. The checking of names on the petitions, the
11 counting, canvassing, and return of the votes on the question, and
12 other procedures for the election shall be as provided by law or
13 charter. Upon a favorable vote of the city electors, the ordinance
14 shall be effective as specified in the ordinance which may be
15 amended by the governing body of the city following the election to
16 specify July 1 or January 1 as the effective date of the ordinance,
17 if the effective date originally specified in the ordinance is
18 considered impractical or inconvenient for any reason. The
19 provisions in this section for a referendum election, and for
20 delaying the effective date of the ordinance if petitions for a
21 referendum are filed, are not applicable to a city that on January
22 1, 1964 had in effect a valid ordinance levying and imposing an
23 excise tax levied on or measured by income. Notwithstanding any
24 other provision of this act, if an ordinance becomes effective on
25 any date other than January 1, each tax year shall end on December
26 31, and the provisions of the ordinance based on a full tax year
27 are modified accordingly to be applicable to the partial tax year.

4 ~~—— (a) "Consumer price index" means the Detroit consumer price~~
5 ~~index for all urban consumers as defined and reported by the United~~

8 ~~—— (b) "Income tax revenue growth rate" means a number the~~
9 ~~numerator of which is the income tax collections of the city for~~
10 ~~the city fiscal year immediately preceding the city's application~~
11 ~~under subsection (3) and the denominator of which is the product of~~
12 ~~the income tax collections of the city for the city fiscal year~~
13 ~~immediately preceding the city fiscal year used to determine the~~

22 ~~which the data is available.~~

23 ~~—— (d) "Statewide tax base growth rate" means the total taxable~~
24 ~~value of real property and personal property in the state for the~~
25 ~~most recent year for which the data is available divided by the~~
26 ~~total taxable value of real property and personal property in the~~
27 ~~state for the second year immediately preceding the most recent~~
