September 15, 2011, Introduced by Reps. Durhal, Talabi, Cavanagh, Irwin, Townsend, Liss, Howze, Hammel, Switalski, Constan, Lindberg, Tlaib, Bauer, Kandrevas, Bledsoe, Stanley, Dillon, McCann, Stapleton, Brunner, Smiley, Haugh, Meadows and Oakes and referred to the Committee on Appropriations.

A bill to make, supplement, and adjust appropriations for various state departments and agencies for the fiscal year ending September 30, 2012; and to provide for the expenditure of the appropriations.
