

HOUSE BILL No. 4984

September 15, 2011, Introduced by Reps. Irwin, Liss, Ananich, Brown, Smiley, Hovey-Wright, Rutledge, Geiss, Slavens, Stapleton, Horn, Townsend, Stallworth, Lipton, Tlaib and Oakes and referred to the Committee on Tax Policy.

A bill to amend 1967 PA 281, entitled
"Income tax act of 1967,"
(MCL 206.1 to 206.713) by adding section 277.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 277. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
2 2011, A TAXPAYER WHO IS A TEACHER WHO TEACHES AT A PUBLIC SCHOOL OR
3 PUBLIC SCHOOL ACADEMY MAY CLAIM A CREDIT AGAINST THE TAX IMPOSED BY
4 THIS ACT EQUAL TO THE COST PAID BY THE TAXPAYER IN THE TAX YEAR NOT
5 TO EXCEED \$1,000.00 FOR A SINGLE RETURN OR \$2,000.00 FOR A JOINT
6 RETURN FOR CLASSROOM SUPPLIES USED BY THE TAXPAYER FOR EDUCATIONAL
7 PURPOSES THAT DIRECTLY RELATE TO THE TAXPAYER'S CLASSROOM COURSE
8 WORK AT THE PUBLIC SCHOOL OR PUBLIC SCHOOL ACADEMY.

9 (2) IF THE CREDIT ALLOWED UNDER THIS SECTION EXCEEDS THE TAX
10 LIABILITY OF THE TAXPAYER FOR THE TAX YEAR, THAT PORTION THAT

1 EXCEEDS THE TAX LIABILITY SHALL NOT BE REFUNDED.

2 (3) AS USED IN THIS SECTION:

3 (A) "CLASSROOM SUPPLIES" MEANS ANY OF THE FOLLOWING:

4 (i) BOOKS FOR TEACHER OR STUDENT USE, BOOKS ON TAPES,
5 VIDEOTAPES, CDS, OR DVDS.

6 (ii) COMPUTER PROGRAMS OR DOWNLOADS.

7 (iii) EQUIPMENT, INCLUDING, BUT NOT LIMITED TO, TAPE RECORDERS,
8 HEADPHONES, SCIENCE EQUIPMENT, AND LAB EQUIPMENT.

9 (iv) ART SUPPLIES.

10 (v) CLASSROOM DECORATIVE MATERIALS.

11 (vi) FOOD AND OTHER SUPPLIES OR MATERIALS FOR EXPERIMENTS OR
12 PROJECTS CARRIED OUT IN THE CLASSROOM.

13 (vii) PRIZES, AWARDS, OR REWARDS.

14 (viii) OTHER SUPPLIES OR MATERIALS SIMILAR TO THOSE LISTED IN
15 THIS SUBDIVISION.

16 (B) "PUBLIC SCHOOL" AND "PUBLIC SCHOOL ACADEMY" MEAN THOSE
17 TERMS AS DEFINED IN SECTION 5 OF THE REVISED SCHOOL CODE, 1976 PA
18 451, MCL 380.5.
