

HOUSE BILL No. 5706

July 16, 2014, Introduced by Reps. Glardon, Somerville, Graves, Franz and Kelly and referred to the Committee on Local Government.

A bill to amend 1951 PA 33, entitled

"An act to provide police and fire protection for townships and for certain areas in townships, certain incorporated villages, and certain cities; to authorize contracting for fire and police protection; to authorize the purchase of fire and police equipment, and the maintenance and operation of the equipment; to provide for defraying the cost of the equipment; to authorize the creation of special assessment districts and the levying and collecting of special assessments; to authorize the issuance of special assessment bonds in anticipation of the collection of special assessments and the advancement of the amount necessary to pay such bonds, and to provide for reimbursement for such advances by reassessment if necessary; to authorize the collection of fees for certain emergency services in townships and other municipalities; to authorize the creation of administrative boards and to prescribe their powers and duties; to provide for the appointment of traffic officers and to prescribe their powers and duties; and to repeal acts and parts of acts,"

by amending section 6a (MCL 41.806a), as added by 1990 PA 102.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 6a. (1) ~~The~~ **SUBJECT TO SUBSECTION (3),** THE legislative

1 body of a municipality providing emergency police or fire service
2 or the legislative bodies of municipalities acting jointly to
3 provide ~~such a~~ **EMERGENCY POLICE OR FIRE** service pursuant to this
4 act may authorize by ordinance the collection of fees for the
5 service.

6 (2) ~~The~~ **SUBJECT TO SUBSECTION (3), THE** township board of a
7 township or the county board of commissioners of a county providing
8 emergency ambulance and inhalator service alone or jointly with
9 another municipality and the legislative body of such a
10 municipality may authorize by ordinance the collection of fees for
11 the service.

12 (3) **A MUNICIPALITY SHALL NOT ENACT, MAINTAIN, OR ENFORCE AN**
13 **ORDINANCE, REGULATION, OR RESOLUTION THAT ALLOWS THE MUNICIPALITY**
14 **TO CHARGE A FEE TO AN INDIVIDUAL, OR THAT ALLOWS THE MUNICIPALITY**
15 **TO SEEK REIMBURSEMENT FOR COSTS FROM AN INDIVIDUAL, FOR THE**
16 **MUNICIPALITY PROVIDING EMERGENCY POLICE OR FIRE SERVICE OR**
17 **EMERGENCY AMBULANCE AND INHALATOR SERVICE AT A MOTOR VEHICLE**
18 **ACCIDENT.**
