by amending section 470 (MCL 18.1470), as added by 2012 PA 230.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 470. (1) Beginning January 1, 2013, if a state agency

enters into a procurement contract for services, the contract shall provide that the department or its designee may audit the vendor to verify compliance with the contract. The financial and accounting records associated with the contract shall be made available to the department or its designee and the auditor general, upon request, during the term of the contract and any extension of the contract and for 3 years after the later of the expiration date or final payment under the contract. The department and its designee shall not audit any matters outside the scope of the individual contract
