A bill to amend 1994 PA 295, entitled "Sex offenders registration act,"

(MCL 28.721 to 28.736) by adding section 9a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 9A. (1) AN INDIVIDUAL WHO IS REGISTERED UNDER THIS ACT
- 2 FOR COMMITTING A LISTED OFFENSE AGAINST AN INDIVIDUAL WAS LESS THAN
- 3 16 YEARS OF AGE AT TIME THE OFFENSE WAS COMMITTED SHALL NOT DO ANY
- 4 OF THE FOLLOWING DURING THE PERIOD IN WHICH HE OR SHE IS REQUIRED
- 5 TO BE REGISTERED UNDER THIS ACT:
- 6 (A) DISTRIBUTE CANDY OR ANY OTHER FOOD OR GIFT ITEMS DIRECTLY
- TO ANY INDIVIDUAL WHO IS LESS THAN 16 YEARS OF AGE. THIS
- 8 SUBDIVISION DOES NOT PROHIBIT THE INDIVIDUAL FROM DISTRIBUTING
 - CANDY OR ANY OTHER FOOD OR GIFT ITEM TO ONLY HIS OR HER SIBLING,

- 1 CHILD, OR WARD, OR TO AN INDIVIDUAL LESS THAN 16 YEARS OF AGE WHO
- 2 RESIDES IN THE SAME HOUSEHOLD AS THAT INDIVIDUAL, UNLESS THE

- 11 WHO RESIDES IN THE SAME HOUSEHOLD AS THAT INDIVIDUAL, UNLESS THE

- 15 GATHERING THAT IS CONDUCTED TO CELEBRATE A BIRTHDAY OR OTHER
- 16 ACHIEVEMENT OF AN INDIVIDUAL LESS THAN 16 YEARS OF AGE OR THAT IS
- 17 COMPOSED PRIMARILY OF INDIVIDUALS LESS THAN 16 YEARS OF AGE. THIS
- 18 SUBDIVISION DOES NOT PROHIBIT THE INDIVIDUAL FROM PERFORMING A
- 19 FUNCTION AT A GATHERING OF ONLY HIS OR HER SIBLINGS, CHILDREN, OR
- 20 WARDS, OR INDIVIDUALS LESS THAN 16 YEARS OF AGE WHO RESIDE IN THE
- 21 SAME HOUSEHOLD AS THAT INDIVIDUAL, UNLESS THE INDIVIDUAL IS
- 22 PROHIBITED BY COURT ORDER FROM HAVING CONTACT WITH ANY OF THOSE
- 23 SIBLINGS, CHILDREN, WARDS, OR INDIVIDUALS LESS THAN 16 YEARS OF
- 24 AGE.
