**GENERAL SECTIONS**

23 Sec. 201. In accordance with the provisions of section 30 of  
24 article IX of the state constitution of 1963, total state spending  
25 from state resources in this appropriation act for the fiscal year

as amended April 27, 2017

1 ending September 30, 2017 is \$<<[1,000,000.00]>>and state appropriations  
2 paid to local units of government are \$<<[0.00]>>.

3       Sec. 202. The appropriations made and expenditures authorized  
4 under this act and the departments, commissions, boards, offices,  
5 and programs for which appropriations are made under this act are  
6 subject to the management and budget act, 1984 PA 431, MCL 18.1101  
7 to 18.1594.

### 8 ENVIRONMENTAL QUALITY

9       Sec. 301. The unexpended funds appropriated in part 1 for the  
10 water infrastructure improvements for the nation act program are  
11 considered work project appropriations, and any unencumbered or  
12 unallotted funds are carried forward into the succeeding fiscal  
13 year. The following is in compliance with section 451a(1) of the  
14 management and budget act, 1984 PA 431, MCL 18.1451a:

15       (a) The purpose of the projects to be carried forward is to  
16 provide water infrastructure improvements.

17       (b) The projects will be accomplished by contract.

18       (c) The total estimated cost of all projects is  
19 \$100,000,000.00.

20       (d) The tentative completion date is September 30, 2021.

21       Sec. 302. From the funds appropriated in part 1, the  
22 department shall provide quarterly reports to the speaker of the  
23 house, the house minority leader, the senate majority leader, the  
24 senate minority leader, and the house and senate fiscal agencies on  
25 the expenditures from the \$100,000,000.00 in federal funds for the  
26 water infrastructure improvements for the nation act program. The

1 reports shall be submitted by June 15, September 15, December 15,  
2 and March 15, for each fiscal year during which the funds are  
3 expended. Each quarterly report shall include, but is not limited  
4 to, all of the following:

- 5 (a) The total amount of funds spent each quarter.
- 6 (b) The specific purpose or purposes for which the funds were  
7 spent.
- 8 (c) The number of structures that had lead service lines  
9 replaced and the average cost per replacement.
- 10 (d) An estimate of the amount of time remaining for project  
11 completion.
- 12 (e) An estimate of the unexpended amount of total water  
13 infrastructure improvements for the nation act appropriations and  
14 state matching dollars that are still available.

15 **LEGISLATURE**

16 Sec. 401. The funds appropriated in part 1 for the State  
17 Capitol Historic Site shall be used to reimburse the senate and  
18 house of representatives for a transfer that was used for Capitol  
19 improvements.
