

**HOUSE SUBSTITUTE FOR
SENATE BILL NO. 425**

A bill to amend 1954 PA 116, entitled
"Michigan election law,"
(MCL 168.1 to 168.992) by adding section 509ii.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 **SEC. 509II. (1) THE SECRETARY OF STATE SHALL DEVELOP AND**
2 **MAINTAIN AN ELECTRONIC VOTER REGISTRATION INTERFACE TO ALLOW AN**
3 **APPLICANT TO SUBMIT A VOTER REGISTRATION APPLICATION ELECTRONICALLY**
4 **THROUGH THE SECRETARY OF STATE'S WEBSITE. THE ELECTRONIC VOTER**
5 **REGISTRATION INTERFACE MUST DO ALL OF THE FOLLOWING:**
6 **(A) TRANSMIT THE APPLICATION TO THE QUALIFIED VOTER FILE.**
7 **(B) INTERACT WITH THE STATE OPERATOR'S OR CHAUFFEUR'S LICENSE**
8 **FILE, ENHANCED DRIVER LICENSE FILE, OFFICIAL STATE PERSONAL**
9 **IDENTIFICATION CARD FILE, AND ENHANCED STATE PERSONAL**

1 IDENTIFICATION CARD FILE FOR AUTHENTICATION PURPOSES.

2 (C) AUTHENTICATE THE IDENTITY OF AN APPLICANT UNDER A PROCESS
3 DEVELOPED BY THE SECRETARY OF STATE THAT INCLUDES, BUT IS NOT
4 LIMITED TO, VERIFYING ALL OF THE FOLLOWING:

5 (i) THE LAST 4 DIGITS OF THE APPLICANT'S SOCIAL SECURITY
6 NUMBER.

7 (ii) THE APPLICANT'S OPERATOR'S OR CHAUFFEUR'S LICENSE NUMBER,
8 ENHANCED DRIVER LICENSE NUMBER, OFFICIAL STATE PERSONAL
9 IDENTIFICATION CARD NUMBER, OR ENHANCED OFFICIAL STATE PERSONAL
10 IDENTIFICATION CARD NUMBER.

11 (iii) THE APPLICANT'S FULL NAME AS PRINTED ON HIS OR HER
12 OPERATOR'S OR CHAUFFEUR'S LICENSE, ENHANCED DRIVER LICENSE,
13 OFFICIAL STATE PERSONAL IDENTIFICATION CARD, OR ENHANCED OFFICIAL
14 STATE PERSONAL IDENTIFICATION CARD.

15 (iv) THE APPLICANT'S DATE OF BIRTH.

16 (v) THE APPLICANT'S EYE COLOR AS PRINTED ON HIS OR HER
17 OPERATOR'S OR CHAUFFEUR'S LICENSE, ENHANCED DRIVER LICENSE,
18 OFFICIAL STATE PERSONAL IDENTIFICATION CARD, OR ENHANCED OFFICIAL
19 STATE PERSONAL IDENTIFICATION CARD.

20 (D) REQUIRE THE APPLICANT'S ASSENT TO SUBMIT A VOTER
21 REGISTRATION APPLICATION ELECTRONICALLY AND REQUIRE THE APPLICANT'S
22 ASSENT TO USE HIS OR HER MOST RECENT DIGITIZED SIGNATURE IF
23 CAPTURED OR REPRODUCED BY THE SECRETARY OF STATE UNDER SECTION 307
24 OF THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.307, SECTION 5
25 OF THE ENHANCED DRIVER LICENSE AND ENHANCED OFFICIAL STATE PERSONAL
26 IDENTIFICATION CARD ACT, 2008 PA 23, MCL 28.305, OR 1972 PA 222,
27 MCL 28.291 TO 28.300.

1 (E) ISSUE A RECEIPT TO THE APPLICANT IN THE MANNER PRESCRIBED
2 BY THE SECRETARY OF STATE.

3 (F) UTILIZE ADDITIONAL SECURITY FEATURES CONSIDERED
4 APPROPRIATE BY THE SECRETARY OF STATE OR THE DEPARTMENT OF
5 TECHNOLOGY, MANAGEMENT, AND BUDGET TO PREVENT UNAUTHORIZED ACCESS
6 TO DATA OR INFORMATION, OR TO ENSURE THAT A PERSON ATTEMPTING TO
7 USE THE ELECTRONIC VOTER REGISTRATION INTERFACE IS AN INDIVIDUAL.

8 (2) THE SECRETARY OF STATE SHALL DEVELOP AN ELECTRONIC VOTER
9 REGISTRATION APPLICATION THAT INCLUDES ALL OF THE SAME INFORMATION
10 AS PROVIDED ON THE MAIL REGISTRATION FORM DEVELOPED BY THE
11 SECRETARY OF STATE UNDER SECTION 509N(A), AND ALSO INCLUDES THE
12 NOTICE REQUIRED UNDER SECTION 307(1)(C) OF THE MICHIGAN VEHICLE
13 CODE, 1949 PA 300, MCL 257.307.

14 (3) ONLY AN INDIVIDUAL WHO POSSESSES BOTH OF THE FOLLOWING IS
15 ELIGIBLE TO SUBMIT AN ELECTRONIC VOTER REGISTRATION APPLICATION:

16 (A) THE QUALIFICATIONS OF AN ELECTOR AS PROVIDED IN SECTION
17 492.

18 (B) A VALID OFFICIAL STATE PERSONAL IDENTIFICATION CARD ISSUED
19 UNDER 1972 PA 222, MCL 28.291 TO 28.300, AN ENHANCED OFFICIAL STATE
20 PERSONAL IDENTIFICATION CARD ISSUED UNDER THE ENHANCED DRIVER
21 LICENSE AND ENHANCED OFFICIAL STATE PERSONAL IDENTIFICATION CARD
22 ACT, 2008 PA 23, MCL 28.301 TO 28.308, A VALID OPERATOR'S OR
23 CHAUFFEUR'S LICENSE ISSUED UNDER THE MICHIGAN VEHICLE CODE, 1949 PA
24 300, MCL 257.1 TO 257.923, OR AN ENHANCED DRIVER LICENSE ISSUED
25 UNDER THE ENHANCED DRIVER LICENSE AND ENHANCED OFFICIAL STATE
26 PERSONAL IDENTIFICATION CARD ACT, 2008 PA 23, MCL 28.301 TO 28.308.

27 (4) IF AN ELECTOR UTILIZES THE ELECTRONIC VOTER REGISTRATION

1 INTERFACE TO INDICATE A CHANGE OF ADDRESS, THE STATE BUREAU OF
2 ELECTIONS SHALL SEND A CONFIRMATION NOTICE TO THE ELECTOR'S
3 PREVIOUS ADDRESS.

4 (5) AN INDIVIDUAL IS NOT PERMITTED TO USE THE ELECTRONIC VOTER
5 REGISTRATION INTERFACE IF THE INDIVIDUAL MEETS ANY OF THE FOLLOWING
6 CONDITIONS:

7 (A) THE INDIVIDUAL ORDERED A DUPLICATE OF AN OPERATOR'S OR
8 CHAUFFEUR'S LICENSE, AN ENHANCED DRIVER LICENSE, AN OFFICIAL STATE
9 PERSONAL IDENTIFICATION CARD, OR AN ENHANCED OFFICIAL STATE
10 PERSONAL IDENTIFICATION CARD THE SAME DAY AS SUBMITTING AN
11 ELECTRONIC VOTER REGISTRATION APPLICATION.

12 (B) THE INDIVIDUAL SUBMITTED A CHANGE OF ADDRESS FOR AN
13 OPERATOR'S OR CHAUFFEUR'S LICENSE, AN ENHANCED DRIVER LICENSE, AN
14 OFFICIAL STATE PERSONAL IDENTIFICATION CARD, OR AN ENHANCED
15 OFFICIAL STATE PERSONAL IDENTIFICATION CARD WITHIN THE 10 DAYS
16 BEFORE SUBMITTING AN ELECTRONIC VOTER REGISTRATION APPLICATION.

17 (C) THE INDIVIDUAL HAS AN EXPIRED OPERATOR'S OR CHAUFFEUR'S
18 LICENSE, AN EXPIRED ENHANCED DRIVER LICENSE, AN EXPIRED OFFICIAL
19 STATE PERSONAL IDENTIFICATION CARD, OR AN EXPIRED ENHANCED OFFICIAL
20 STATE PERSONAL IDENTIFICATION CARD.

21 Enacting section 1. This amendatory act takes effect 90 days
22 after the date it is enacted into law.

23 Enacting section 2. This amendatory act does not take effect
24 unless all of the following bills of the 99th Legislature are
25 enacted into law:
